Nixon places call to Trudeau, 22 Mar 73, in the midst of conversation with Mitchell ("stonewall," "save the plan" conversation). Later, as they talk, transcript shows that phone rings three times, is disregarded, and that a little later Nixon picks up the phone and says, "Hello. I don't want to talk. Sure." Hangs up. This could have been an incoming call from someone else, but it seems reasonable to assume it could have been the operator with Trudeau on the line, or perhaps that Trudeau could not be reached or could not speak with Nixon at that time.

Ervin committee issues staff report which shows that Rebozo used four bank trust accounts in the name of his lawyer, Thomas H.
