Tapes (subpoenaed by Jaworski) - St. Clair turns over to Sirica tapes of the first 20 of the 64 conversations subpoenaed. Asked by Ben-Veniste if any segments of any conversations are missing, says, "Not to my knowledge. These were copied mechanically and I have had no reports of any abnormalities."

However, St. Clair says tape of meeting 14 Apr 73*(Nixon, Haldeman, Ehrlichman) was broken while being copied; says that "rather than gluing it back together, we simply wound it on a new reel." When presenting this tape to Sirica, St. Clair discovers to his surprise that the tape had been spliced, and that the box which he thought contained the second half of the tape is empty. See story (NYT) for account of this incident.

These 20 conversations are on 11 seven-inch reels of original tapes St. Clair also supplies copies of each conversation, so that Sirica in listening to them can find them more easily.
