Nixon (illness) - Dr. Lungren calls news conference to say that Nixon may leave the hospital by the end of the week (this is a Monday) but will not be able to travel for at least a month, possibly three months; 'he will recommend that Nixon not even give a written deposition for two or three weeks. Deposition is needed for cover-up trial, which begins tomorrow. "[A] newsman said there had been questions raised whether Mr. Nixon's hospitalization was inecessary.' Looking grim, Lungren said such a report was in the same classification as the rumors that the illness was a hoax, and said he would not dignify it with a reply."

"Lungren recently had described the blood clot in Mr. Nixon's lung as 'the size of a dime.' The doctor said he wanted to verify [rectify?] that statement by saying that the lung area affected was about dime-size." WXP: "He also said that there was only one clot in [Nixon's] leg, not two as previously stated." Story does not indicate whether Lungren had made such a statement, or whether it was made by someone else.

Ford says in letter to Hungate, chairman of HJC's Subcommittee on Criminal Justice, that he will appear personally before the subcommittee within ten days to answer questions about his pardon of Nixon. Cover-up trial is to begin tomorrow; in final preparation for it, Sirica holds all-day closed hearing. Sirica orders separate later trial for Strachan, rather than delay the trial of the five other defendants with pretrial hearings on Strachan's case. "According to lawyers involved," the main trial will last three to five months.

Haldeman is the only defendant who appears at the hearing; is wearing Presidential tieclasp.

Nixon tapes - Mack Thompson, executive director of the American Historical Association, is one of several witnesses testifying before a House administration subcommittee (no further identification) which is holding hearings on longrange proposals for dealing with Presidential papers. Exampases Thompson says his group and at least two others are considering court action to insure that Nixon tapes and documents are not destroyed, that disposition of the material should be held up until legislation or the courts can deal with the matter.
