Nixon (medical panel) - Sirica appoints panel of three doctors, whose investigation "shall commence forthwith" and who are ordered to submit at least a preliminary report by 29 Nov. Sirica's order says he expects their work to include a "review of pertinent medical records and a physical examination of the witness," tells reporters that he will leave the schedule up to the panel and that "they know time is of the essence." WXP says 29 Nov deadline "reflects forecasts by Watergate prosecutors that they should finish their half of the trial by Thanksgiving." Sirica tells reporters that under court rules the government will pay the "reasonable fees" for the panel's work, probably out of court funds for expert witnesses. 4me-s
