Nixon (no statement on verdicts - see entry 1 Jan) - Story datelined San Clemente says that none of the newsmen gathered there in anticipation of Nixon reaction to verdicts was allowed inside the Nixon estate. "Instead, the following statement was read to them over a telephone in the lobby of a nearby motel:

"'Former President Nixon's attorney has advised him against making any specific statements about yesterday's verdicts, because the defendants have stated their intention to file appeals.

"'President Nixon is deeply anguished by Watergate, and that these men, who were among his closest aides, and their families, have suffered so much, and that their lives have been so tragically touched by Watergate."

Story says that the person who (presumably) read this statement is an "associate" of Nixon's, "who asked to be identified only as someone who has spoken with the former President after the verdict was returned."

He even escaped testifying at the trial just completed because of ill health — an escape no less to be deplored because of its reason ....

"Pardoning some or all of those convicted will not balance the scales. Too many have served time; too much guilt has been forgiven. The hard truth is that justice has not and cannot be done in the Nixon scaldals, because the big enchilada has escaped."

Neal (resignation) - "In Nashville ... the chief Watergate prosecutor, James F. Neal - who resigned as of today to return to his law practice one day after obtaining four convictions in the cover-up trial - [said] in an interview in The Nashville Banner, [that] 'There was no doubt in my mind, absolutely none, of the involvement of President Nixon. I don't think anyone could listen to the tapes and reach any other conclusion.' He added, 'I personally thought [President Ford] was correct, all things comsidered, in pardoning the former President.'"

WXP: "Noting that he had not spoken publicly on the matter before, Neal added, however, 'I thought President Ford's timing was bad. I was shocked and concerned about the timing of the pardon announcement, but I thought his action was correct."
