Nixon - Anderson column on Nixon turning down a deed to a five-acre lot 15 miles southeast of Colorado Springs. Deed is dated 30 Jul 70, signed by James V. House, who said he took the action in an effort to get Nixon's attention in a dispute with the IRS.

Korff (President Nixon Justice Fund) - Undated story; intv with Korff presumably took place today. Story datelined WX.

Fund is almost wiped out by payment yesterday to Nixon's WX lawyers; \$20,000, bringing to \$100,000 paid by the fund for legal fees since Nixon's resignation. ~~\*\*\*~~

"Contributions trickle in daily to the Justice Fund's offices six blocks from the White House. A few are in the \$500 to \$1000 range, but most are smaller. To expand the flow of contributions, Korff said he now is sending scores of letters to newspapers and other publications 'throughout the free world.' The goal is to raise \$1 million to aid the former president, he said in an interview. About \$400,000 to \$500,000 would go to pay current legal fees [etc.]. The rest would supplement 'the meager congressional allotment which by all accounts is less than one-third the amount given to [Johnson],' he said." See entry Nixon, Korff appeal ...

Nixon (Korff appeal for foreign contributions) - See entry, Korff, President Nixon Justice Fund.

Ziegler - At Boston University controversy develops over lecture by Ziegler scheduled for 26 Feb; students support his appearance but faculty members oppose it. Student government had asked Ziegler to speak.

Dean of the School of Public Communication sends a telegram "this week" to student government president, saying he thinks it is "morally wrong" for the students to pay Ziegler to speak; "I would defend Ziegler's right to speak on this campus, but I think it would be a travesty to reward him in any way for his despicable contempt for the Constitution and democratic process." Urges students to rescind its decision to pay Ziegler's lecture fee.

Goldwater has lunch with Nixon - See entry 28 Jan 75, Nixon Wants ....

George Bush, U.S. envoy to Peking, having returned from China temporarily, is in WX during period 23 (?)<sup>Jan</sup> to 6 Feb 75; date of actual return from China not given.

Bush returns to China 6 Feb; says in intv that day that U.S. "[wants] to strive to ... fulfillment" of Shanghai communique. Story suggests upgrading of his post to full ambassadorship.

"Kissinger ... reportedly had previously told the U.S. envoy not to discuss the China situation during his recent two weeks [23 (?) Jan to 6 Feb] in Washington. ... However, [Bush] is believed privately to have advocated rather accommodations with the People's Republic on the Taiwan issue in hopes of moving toward full recognition by the Chinese government." See entry, Kissinger.

Kissinger (Nixon) - State Department says (no date, presumably today) that Kissinger, in California for speech in Los Angeles, will see Nixon this weekend, first meeting since resignation; details of visit not yet complete. Story is printed 24 Jan, a Friday, the same day Kissinger has dinner with the Nixons. (It may be that AP carried the story earlier than today and it was not used by SFC until 24 Jan.)
