Nixon (television intv?) - Nixon is to meet next week in San Clemente with "several people who are interested" in bidding for the rights to a series of taped intvs. Two independent producers are to meet with Nixon. Lazar refuses to name them but "other sources indicate" that one of these is David Frost, "who has reportedly put together a group of British, French and West German backers."

NBC has not been invited to attend, according to its president, Richard Wald, who says the network is not bidding at the price Lazar is reported to be asking \$750,000 for three or four one-hour intvs. Wald says the negotiations between the network and Lazar involve "very strict ground rules," but have progressed to the "preliminary answer" stage.

"Lazar said [today] the former President has told him he is now fully prepared to appear 'in any format - with a single interviewer or panel, whatever - and is prepared to discuss with complete candor, with no ground rules whatsoever, Watergate, domestic policy, foreign policy - anything, of course, except probably some details of his personal life.'
... Lazar said that all negotiations are 'very far from settled,' pointing out that no programs are scheduled to be taped until after the November 1976 presidential elections 'at the earliest,' if a contract is signed."

Baker (break-in) - Baker's house in WX is broken into; house is unoccupied as Baker and his family are in Tennessee. Police and one of Baker's aides say items normally taken by burglars were not stolen, although "every closet, every drawer, including those in the kitchen," was ransacked and contents scattered. Items not stolen include furs, diamond ring, photographic equipment, etc. Police detectives say they do not believe the break-in was the work of professionals because of the way a safe was hacked open.

Baker's press secretary says he has talked with Baker and "as far as we know there were no classified documents in the house" at the time. The manuscript of a book Baker is writing was not taken.
