The Major Events of the Day

International
Ending its week-long deadlock with the Ford Administration, Congress has approved a compromise measure to continue military aid to Turkey until December 10, providing that Turkey does not send American arms to Cyprus. President Ford has told Congressional leaders he will "reluctantly" accept the compromise. [Page 1, Columns 2-3.]

National
In what may have been the first formal appearance by a President before a Congressional panel, President Ford appeared before a House Subcommittee in an attempt to lay at rest suspicions raised by his unconditional pardon of his predecessor, Richard M. Nixon. The pardon, Mr. Ford said, was granted solely "out of my concern to serve the best interests of my country." Then he added, "There was no deal." [1:8.]

The gross national product has declined during the third quarter of this year, the third consecutive three-month period in which a drop was registered, the Commerce Department had reported, adding that the inflation rate has worsened. Secretary of Commerce Frederick B. Dent insisted that the nation is not in a recession, despite the nine-month drop in output. He called the current state of the economy "a spasm" or "sideways warfaring." [1:1.]

Lawyers for former President Richard M. Nixon have asked a Federal District Court in Washington to enforce last month's agreement giving Mr. Nixon personal control over his Presidential tape recordings and papers. The move by the Nixon legal staff came after private negotiations over access to the tapes and papers broke down between lawyers for Mr. Nixon, Special Prosecutor Leon Jaworski and the White House. A major energy study sponsored by the Ford Foundation urges a Government-led commitment to conserve energy and says that, by such an undertaking, this country could put off for 10 years "massive new commitments" to offshore drilling, oil imports, nuclear power and development of coal and shale in the West.
