WASHINGTON AP - Additional contributions to President Nixon's reelection campaign totaling $89,000 found their way into the bank account of one of the men charged with breaking into the Democcatic National Committee headquarters, the Washington Star-News said Friday & A DT.

Quoting sources close to the investigation, , the Star-News said also that federal agents probing the June 17 break-in have found the Republicans established a special security fund, for its national convention.

It was not known, the newspaper said, whether the money came from that fund-ext up to thwart demonstrations.

The $89,000 was deposited in four installments into the account of Bernard Barker, a Miami real estate man and one of the five men arrested in the Democratic headquarters, the Star-News said.

It would raise to $114,000 the amount deposited in Barker's account through the Committee to Re-Elect the President, the newspaper said. Last week a $25,000 campaign check was traced to Barker's account at the Republic National Bank of Miami.

Barker, a Miami real estate man, was one of five men arrested in the Democratic offices. The men carried cameras and bugging equipment, later police confiscated 52 consecutively numbered $100 bills from the8 98 $ 5kaced the money to a large withdrawal Barker had made from his bank.
