Barker Bjt NL 330 Two Takes Total 630

MIAMI, Fla. AP - Bernard L. Barker, one of five men accused of breaking into Democratic National Headquarters in Washington, D. C., pleaded innocent Friday to fraudulently notarizing a \$25,000 Republican campaign check.

The former CIA operative and four other men were seized by police June 17 inside Democratic headquarters in Washington's Watergate complex. They and two other men were indicted Friday by a federal grand jury in Washington on charges of breaking into Democratic headquarters to steal documents and to install electronic bugs to intercept telephone and oral communications.

In the Miami case, Barker was freed on \$1,000 bond and Judge Paul Baker set trial for Oct. 30 on the felony charge, which is punishable by a prison term of up to five years.

Barker was accompanied at his bond hearing in Criminal Court by Henry Rothblatt of New York City, the attorney for the five men.

Rothblatt said the men were motivated by a desire to free Cuba of Communist domination. "People like them are motivated to do things for love of Cuba," he said.

Barker, who reportedly played a role in the abortive Bay of Pigs invasion of Cuba in 1961, said at a news conference after his arraignment: "I'm not ashamed of anything I've done. I don't look at myself as a common burglar."

Barker, 55-year-old Miami resident and a former Cuban national police officer, said, "I'll face the responsibilities as they come up." He added that he counted on "my friends to back me."

Rothblatt said Barker "has always supported a Cuba free of Communist domination and will continue to do so."

State attorney Richard Gerstein of Miami, who filed the felony charge against Barker, said the \$25,000 check was deposited by Barker in his Miami bank account in April. The cashier's check was signed by Kenneth Dahlberg, Midwest finance chairman for the Committee to Re-elect the President, Gerstein said.

Gerstein charged Barker had difficulty in cashing the check and tried to deposit it in his account at Miami's Republic National Bank.

Barker, a notary public, was asked to have Dahlberg's signature notarized by a bank vice president. He returned with the check notarized with his own notary seal, the state attorney said.

Gerstein said Barker had "fraudulently and falsely swore that Dahlberg had signed the check in Barker's presence, when in truth Barker had never met and never seen Dahlberg."

Rothblatt said he did not expect the check case to come to trial before the Nov. 7 presidential election because there were "many legal problems."

Baker set Oct. 13 as the date for hearing motions.

Gerstein disclosed last month that testimony from a Miami commercial photographer indicated there may have been more than one break-in at Democratic headquarters.

Gerstein said the photographer testified that Barker brought him film to be processed as a "rush job" a week before the June 17 Watergate break-in. The photographer said the prints showed what appeared to be correspondence between Democratic party leaders.

The state attorney said the photographer passed a lie detector test "with flying colors," but he has not filed any other charges since the disclosure.

Meanwhile, Sen. Edward M. Kennedy, D-Mass., speaking in Miami Beach before the United Rubber Workers convention, said his judicial subcommittee would forego investigation of the Watergate affair if indictments are returned promptly against Barker and four others.

"Obviously, we would have to pass up any investigation that would conflict with proper court procedure," Kennedy said.
