According to his lawyer, Peter Wolfe (19 Apr 73), Sheppard 18 Jun 72 picked up eight cartons at EOB, including contents of Hunt's desk; pass was waiting for him at guard entrance that morning. Sheppard kept cartons hidden and returned them to CREEP, at its request, "shortly before the election." Wolfe believed that most of the material which was not turned over to the court, as a result of Common Cause suit, had been destroyed (no indication of when, or by whom).

Kehrli says in testimony, Ervin committee, 17 May 73, that the special pass was from Dep't of Transportation.

KPFA News 19 Apr 73 * By 24 (?) Apr 73, Wolfe is referring to Sheppard (although not by name) as his former client. NYTimes 25 Apr 73, Lydon Sheppard described as a low ranking employee in CREEP.

KPFA News 19 Apr 73 Sheppared described as a former campaign worker, CREEP, now employed by a trucking firm. WXPost 30 May 73, Meyer and Robinson

According to his lawyer, Ben Cotton, Sheppard said (26 Jun 73) that he picked up eight cartons* from a woman he now believes to be - from news photos** Mrs. Hunt, who contacted him shortly after the Watergate break-in. (No date on when he met her at the airport and picked up the cartons.)

Sheppard kept cartons in his home in Alexandria; did not open cartons until Nov 72, when he burned them, because no one had asked about them. Cotton said Sheppard testified to the above to Senate Watergate investigating committee and Watergate grand jury (no dates).
Sheppard described (by Cotton?)

as operator of Washington-based delivery service.

According to Jack Anderson. Hunt obtained clearances to move eight sealed cartons out of White House (no date), then arranged for Sheppard to pick them up and keep them in his basement. In Aug 72 Hunt contacted Sheppard, who returned the boxes (no indication to whom returned).

Sheppard described by Anderson as a trusted associate of Hunt's and a federal employee.

Left Washington 1 Jun 72, with two children, for vacation in London and Paris.

Returned to work at Spanish Embassy, Washington, 20 Jun 72.** Ended employment at Embassy, 30 Jun 72.

NYTimes 3 Jul 72, Szulc, quoting Embassy officials Had worked at Embassy 11 years, according to Ambassador Angel Sagaz. Went on holiday to Europe (no date) with one daughter and a son, returned "about one week before her husband was caught." Later that day he asked her to leave, and she left (did not return to work?) the following day.

E. Howard Hunt

Was ordered by Dean to leave the country "two days" (19? Jun 72) after Watergate break-in, according to Colson, who said he countermanded the plan.
