ON NIXON'S HOMES

Also Votes to End Special White House Fund and Part of Agnew's Staff

WASHINGTON, Aug. 1 The House agreed today to bar further "security" improve-ments on President Nixon's "security" private homes at Key Biscayne, Fla., and San Clemente, Calif., without specific Congressional approval.

The House also agreed to wipe out a traditional \$1.5-million "special projects" White House fund, which the Nixon Administration used to pay the \$100-a-day consulting fee to E. Howard Hunt Jr., one of the convicted Watergate conspirators.

As passed by voice vote and sent to the Senate, a \$4.8-bil-lion appropriations bill to finance the White House, Postal Service and Treausry held little but bad news for the President.

Among other things, the bill would wipe out Vice President Agnew's 30-member staff in the Executive Office Building. This staff administers special functions assigned to the Vice President by the President.

The bill would also take away the President's power to set special per diem rates for Continued on Page 19, Column 1
