## Witness Says Agnew Got Road Contract Kickbacks

BALTIMORE, Jan. 23 - A former Maryland Roads Comformer Maryland Roads Com-mission chairman testified in Federal Court here today that he was involved in the extor-tion of cash kickbacks from 1967 to 1969 with former Vice President Spiro T. Agnew and a Baltimore mortgage banker. The witness, Jerome B. Wolff, 55 years old, served as com-mission chairman while Mr. Ag-new was Governor of Maryland

Mr. Wolff's description of the al-leged kickbacks came on the 10th day of a political cor-ruption trial of N. Dale Ander-son, Baltimore County Execu-tive.
