Jury Sifts Charge Schwenk Put Pressure on a Bank for Loan to Realty Man

A Federal grand jury in Brooklyn is investigating the Suffolk County Republican leader, Edwin M. Schwenk, for possible violations of Federal extortion and interstate commerce statutes, sources close the investigation said to yesterday.

The investigation stems from allegations that Mr. Schwenk tried to use his influence as county Republican chairman to county Republican chairman to put pressure on officers of the Franklin National Bank to give: a \$1-million unsecured loan to George Tobler, a Smithtown insurance man active in Republican politics. The sources said that officers of the Franklin National Bank had been questioned by agents of the Federal Bureau of In-vestigation following up on allegations that Mr. Schwenk had hinted to the officers that he would exert political pres-sure if Mr. Tobler were not given the loan. In February of 1973, a wel-fare fund of between \$3-million and \$4-million was withdrawn from the Franklin National Bank by the county treasurer. The money was deposited in Security National Bank, in a noninterest-bearing account. The sources said that several fronths before the transfer of the welfare fund, the officers of Franklin National Bank had refused to give Mr. Tobler a loan but that he had success-fully obtained a \$1-million loan from Security National Bank. Mr. Schwenk said yesterday that he had introduced Mr. Fobler to the officers of Frank-lin National Bank during the winter of 1971-1972, when Mr. Tobler was seeking the loan. "Tve done nothing wrong," Mr. Schwenk said, adding, in response to a question, that he had not tried to put any pres-sure on the officers of the bank in behalf of Mr. Tobler. "Either the loan should stand on its merits or it wouldn't, and that's the way it should be," Mr. Schwenk said. He recalled that he made the introduction for Mr. Tobler at the request of the late Sidney Hein, former Queens County Republican chairman, who was friendly with Mr. Tobler.
