WASHINGTON, July v8-Following is the text of a personal memo prepared by David R. Young, an aide to John D. Ehrlichman, for himself after a meeting with his superior. The memo, reflecting both Mr. Young's and Mr. Ehrlichman's concern that they not be pressed on whether information about the plumber's operation had been passed to the President.

E was aware of Hunt and Liddy going to California to undertake further extensive investigation to determine whether dealing with network or conspiracy. That this might involve covert operations.
E was not asked if he approved their going. He was asked if he knew of the results and whether he approved further actions. He said disapproved further actions.
DY said to E that only thing bothers him is "you didn't say you approved beforehand." E/They didn't ask me! Y/ I made substantive decision that it was beyond my responsibility to do

anything about it. I passed recommendation to him. He should have passed recommendation on up if he thought

No one at WH knew.
