Watergate Convictions

WASHINGTON, Aug. 2—Following are the defendants who have received prison sentences as a result of conviction in Watergate-related cases.

- Bernard L. Barker, sentenced Nov. 9, 1973, to 18 months to six years, in the original Watergate burglary trial.
- Dwight L. Chapin, the President's former appointments secretary, sentenced May 15, 1974, to 10 to 30 months, after conviction at trial for making false statements.
- Charles W. Colson, former counsel to the President, sentenced June 21, 1974, to one to three years in prison and fined \$5,000 after pleading guilty to obstruction of justice.
- John D. Ehrlichman, the President's former chief domestic adviser, sentenced July 31, 1974, to 20 months to five years, after conviction for perjury and conspiracy in "plumbers" trial.
- Virgilio R. Gonzalez, sentenced Nov. 9, 1973, to one to four years, in original Watergate trial. Released on parole March 7, 1974.
- E. Howard Hunt Jr., sentenced Nov. 9, 1973, to 30 months to eight years in original Watergate case.
- Herbert W. Kalmbach, Mr. Nixon's personal attorney, sentenced to six to 18 months and fined \$10,000 after pleading guilty to charges relating to promising Federal employment as a reward for campaign contributions.
- Richard G. Kleindienst, former Attorney General, sentenced to a 30-day prison term and \$100 fine, after pleading to a misdemeanor count of failing to testify fully before the Senate. Sentence suspended in full.
- Egil Krogh Jr., sentenced on Jan. 24, 1974, to two to six years, all but six months of which were suspended, after pleading guilty to a charge of violating rights in the plumbers case.
- G. Gordon Liddy, sentence Nov. 9, 1973, to six years and eight months to 20 years in original Watergate case, sentenced on July 31, 1974 to one to three years, to run concurrent with first sentence, after conviction in plumbers case.
- Eugenio R. Martinez, sentenced on Nov. 9, 1973, to one to four years in original Watergate case, paroled March 7, 1974.
- James W. McCord Jr., sentenced Nov. 9, 1973, to one to five years in original Watergate case.
- Jeb Stuart Magruder, deputy director of Committee to Re-elect the President, sentenced on May 21, 1974 to 10 months to four years, after pleading guilty to obstruction of justice.
- Herbert L. Porter, sentenced on April 11, 1974, to five to 15 months, all but 30 days suspended, after pleading guilty to making false statements, released May 23.
- Donald H. Segretti, sentenced Nov. 5, 1973, to six months after pleading guilty to conspiracy and related offenses. Released March 25, 1974.
- Frank A. Sturgis, sentenced Nov. 9, 1973, to one to four years, in original Watergate case.
