## The Coverup

**H. R. Haldeman**, 47, former White House chief of staff, indicted March 1, 1974, one count conspiracy to obstruct justice, three counts perjury and one count obstruction of justice. Pleaded innocent all counts March 9, 1974. Free without bond. Trial rescheduled Sept. 9, 1974.

**John D. Ehrlichman**, 49, former presidential domestic counsel, indicted March 1, 1974, one count conspiracy to obstruct justice, one count lying to FBI agents, Trial scheduled Sept. 9, 1974.

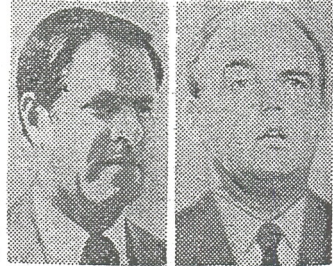

**John N. Mitchell**, 61, former attorney general, indicted March 1, 1974, one count conspiracy to obstruct justice, two counts lying to grand jury, one count perjury, one count lying to FBI agents and one count obstruction of justice. Pleaded innocent all counts March 9, 1974. Free without bond.

**Charles W. Colson**, 42, for-

mer White House special counsel, indicted March 1, 1974, one count conspiracy to obstruct justice and one count obstruction of justice. Pleaded innocent both counts March 9, 1974. Charges dismissed June 21, 1974 as result of plea in Ellsberg trial case.

**Robert C. Mardian**, 50, former assistant attorney general, indicted March 1, 1974, one count conspiracy to obstruct justice. Pleaded innocent March 9, 1974. Free without bond. Trial scheduled Sept. 9, 1974.

**Kenneth W. Parkinson**, 46, attorney for President Nixon's campaign committee, indicted March 1, 1974, one count conspiracy to obstruct justice and one count obstruction of justice. Pleaded innocent both counts March 9, 1974. Free without bond. Trial scheduled Sept. 9, 1974.

**Gordon C. Strachan**, 30, former presidential assistant, indicted March 1, 1974,

**Frederick C. LaRue**, 45, aide to Mitchell when he directed the 1972 Nixon reelection campaign, pleaded guilty June 27, 1973, to one

count conspiracy to obstruct justice. Sentencing deferred. Free without bond.

**Jeb S. Magruder**, 39, former deputy director of the Committee for the Re-election of the President, pleaded guilty Aug. 16, 1973, to one count conspiracy to obstruct justice and defraud the United States. Sentenced May 21, 1974 to 10 months-to-four years in prison. En-

tered Allenwood, Pa., minimum security facility June 4, 1974.

**John W. Dean III**, 35, ousted as counsel to the President April 30, 1973, pleaded guilty Oct. 19, 1973, to one count conspiracy to obstruct justice and defraud the United States. Sentenced Aug. 2, 1974 to 1-4 years in prison; term scheduled to begin Sept. 3. Free without bond.

**Herbert L. Porter**, 35, scheduling director for CRP charged Jan. 21, 1974, one count making "false, fictitious and fraudulent statements and representations" to FBI agents July 19, 1972. Pleaded guilty Jan. 28, 1974. Sentenced April 11, 1974 to serve 30 days of a 5-15 month sentence; served at minimum security facility, Lompoc, Calif., April 22 to May 17, 1974.

# The Plumbers Cases

## Federal

**Egil Krogh Jr.**, 34, former assistant to John D. Ehrlichman, sentenced Jan. 24 to serve six months of a 2-6 year term. Pled guilty Nov. 30, 1973, one count violating the rights of Dr. Lewis Fielding, Daniel Ellsberg's psychiatrist, in the Sept. 3-4, 1971 break-in at Fielding's office. California state charges dropped after plea in federal case. Began sentence at Allenwood, Pa., prison farm Feb. 4, 1974. Released June 21, 1974 with time off for good behavior.

**Ehrlichman**, indicted March 7, 1974, one count conspiracy to violate Fielding's rights; one count lying to the FBI; three counts lying to grand jury. Pled innocent all counts March 9, 1974. Trial began June 26, 1974. Convicted July 12 on all but one count of lying to grand jury. Lying to the FBI charge dismissed July 22. Sentenced July 31, 1974 to 20 months to 5 years in prison. Free without bond pending appeal.

**Colson**, indicted March 7, 1974, one count conspiracy to violate Fielding's rights.

Pled innocent March 9, 1974. Pled guilty June 3, 1974 one count obstruction of justice in connection with the original Ellsberg trial. Sentenced June 21, 1974 to 1-3 years in prison and fined \$5,000. Conspiracy charge dismissed same day. Began serving sentence July 8, 1974. Disbarred from practice in U.S. District Court for the District of Columbia, June 25, 1974.

**G. Gordon Liddy**, 44, Oxon Hill, Md., former White House aide, indicted March 7, 1974, one count conspiracy to violate Fielding's rights.

Pled innocent March 14, 1974. Trial began June 26, 1974. Convicted July 12, sentenced July 31, 1974 to 1-3 years, term to run concurrently with break-in sentence.

Liddy indicted also two counts refusing testify before Intelligence Subcommittee of House Committee on Armed Services. Pled innocent March 14, 1974. Convicted after bench trial May 10, 1974; two concurrent six months sentences, concurrent also with other sentences, suspended. Probation, initially imposed,

lifted May 23, 1974. In D.C. jail.

**Bernard L. Barker**, 57, Miami, Fla. indicted March 7, 1974, one count conspiracy to violate Fielding's rights. Pled innocent March 14, 1974. Trial began June 26, 1974. Convicted July 12, sentenced July 31, 1974 to 3 years probation.

**Felipe DeDiego**, 45, Miami, Fla., indicted March 7, 1974, one count conspiracy to violate Fielding's rights. Pled innocent March 14, 1974. Indictment dismissed by U.S. District Judge Ger-

**Eugenio Martinez**, 52, Miami, Fla., indicted March 7, 1974, one count conspiracy to violate Fielding's rights. Pled innocent March 14, 1974. Free without bond under parole conditions. Trial began June 26, 1974. Convicted July 12; sentenced July 31, 1974 to 3 years probation.

## State

**Ehrlichman**, pleaded innocent Sept. 7, 1973, California charges conspiracy, burglary and perjury in Fielding break-in. All except perjury charge dismissed March 13, 1974. Perjury trial scheduled Aug. 15, 1974.

**David R. Young**, 36, former White House aide, pleaded innocent Sept. 20,

1973, California state charges burglary and conspiracy to commit burglary in Fielding break-in. Charges dismissed March 13, 1974.

**Liddy**, pleaded innocent Sept. 20, 1973, California state charges burglary and conspiracy to commit burglary in Fielding break-in. Charges dismissed March 13, 1974.

# Political Contributions

Herbert W. Kalmbach, 52, President Nixon's personal lawyer pleaded guilty Feb. 25, 1974, one felony count charging violation Federal Corrupt Practices Act based on hidden campaign that raised \$3.9 million for Republican congressional can-

didates in 1970; and one misdemeanor count promising an ambassador a better post for \$100,000 campaign contribution. Sentenced June 17, 1974 to 6-18 months and a \$10,000 fine on the felony count and 6 months on the misdemeanor count, to be

served concurrently. Began sentence July 1, 1974.

Mitchell, former attorney general and Nixon reelection campaign director, pleaded innocent May 21, 1973, one count conspiracy to obstruct justice; three counts endeavoring obstruct

justice; five counts grand jury perjury. Trial in New York federal court began Feb. 19, 1974. Acquitted April 28 on all counts

Maurice H. Stans, 65, pleaded innocent May 21, 1973, to one count of conspiracy to obstruct justice;

three counts of endeavoring to obstruct justice; six counts of perjury before a grand jury. Trial in New York federal court began Feb. 19, 1974. Acquitted all counts April 28, after 48-day trial.

Robert Vesco, 37, indicted

May 10, 1973, one count conspiracy to obstruct justice; three counts endeavoring to obstruct justice; Vesco, a fugitive. Charges pending.

Harry L. Sears, 53, former Republican majority leader New Jersey Senate and chairman Nixon campaign

that state, pleaded innocent May 21, 1973, one count conspiracy to obstruct justice and three counts endeavor-

ing to obstruct justice. Sears granted total immunity and charges expected to be dismissed.

## The Milk Fund

John B. Connally, 57, Houston, Tex., indicted July 29, 1974, two counts accepting a bribe; one count conspiracy to commit perjury and obstruct justice; two counts lying to grand jury. Arraignment scheduled Aug. 9, 1974.

Jake Jacobsen, 54, Austin,

Tex., indicted Feb. 21, 1974, one count making false statement to a federal grand jury. Pled innocent March 15, 1974. Indictment dismissed May 3, 1974.

Jacobsen reindicted July 29, 1974, one count paying bribe. Pled guilty Aug. 7, 1974 in return for a prosecution promise to drop charges

against him in an unrelated savings and loan scandal in San Angelo, Tex., and to accuse him no further in the milk fund case. Free without bond.

Harold S. Nelson, 56, San Antonio, Tex., former general manager of Associated Milk Producers, Inc., plead-

ed guilty July 31, 1974 to one count of making an illegal campaign contribution and making an illegal payment to a public official. Sentencing deferred. Free without bond.

David L. Parr, Little Rock, Ark., former second in command of Associated Milk Producers, Inc., plead-

ed guilty July 23, 1974 to one count conspiracy to donate corporate money and services illegally. Sentencing deferred. Free without bond.

## ITT Case

Howard Edwin Reinecke, 50, lieutenant governor of California, indicted April 3, 1974 three counts perjury before Senate Judiciary Committee probing possible connection ITT anti-trust settlement and pledge to 1972 GOP campaign. Pled innocent April 10, 1974. Trial began July 15, 1974. Convicted one count perjury

July 27, 1974; one perjury charge dropped before trial, second dismissed July 22. Sentencing date August 30. Free without bond.

Richard G. Kleindienst, 50, former attorney general, pleaded guilty May 16, 1974, one count violating Title 2, U.S. Code, Section 192, a misdemeanor. "Refusal of

witness to testify or produce papers." Sentenced June 7, 1974 to one month jail, \$100 fine, both suspended.

First Interoceanic Corp. and chairman Dwayne O. Andreas each pleaded innocent Oct. 19, 1973, four counts illegal campaign contributions. Trial scheduled July 8, 1974.

American Shipbuilding Co. indicted April 5, 1974, one count conspiracy, one count illegal campaign contribution; George M. Steinbrenner III, 43, board chairman and chief executive officer,

indicted one count conspiracy; 5 counts illegal campaign contributions; 2 counts aiding an individual to make false statements to FBI, 4 counts obstruction justice, 2 counts obstruction criminal investigation. Firm and Steinbrenner pleaded innocent April 19, 1974. Trial date not set.

John H. Melcher Jr., executive vice president and general counsel, American

Shipbuilding pleaded guilty April 18, 1974 to accessory after fact to illegal campaign contribution. Fined \$2,500, June 14, 1974.

Northrop Corp. pleaded guilty May 1, 1974 to one count of making an illegal campaign contribution by a contractor, totaling \$150,000, fined \$5,000; Thomas V. Jones, board chairman and chief executive officer fined \$5,000; James Allen, vice

president and assistant to the president fined \$1,000.

Associated Milk Producers, Inc., pleaded guilty Aug. 1, 1974 to one count conspiracy and five counts illegal campaign contributions; fined \$35,000.

John Valentine, Minneapolis, Minn., charged July 30, 1974, one count aiding and abetting an illegal campaign contribution; a misdemeanor

George A. Hearing, 41, Tampa, Fla., pleaded guilty May 11, 1973, two counts fabricating and distributing illegal campaign literature. Sentenced June 15, 1973, one year in prison. Released March 22, 1974 from Eglin
