WASHINGTON, Dec. 30-In a detailed picture of the Gulf Oil Corporation's massive payments to politicians and candidates here and abroad, an independent investigative committee oday described the company's domestic contributions as "shot through with illegality."

"The activity was generally clandestine and in disregard of Federal, as well as a number of state statutes," the threemember panel said in a special report to the Securities and Exchange Commission and the United States Court for the District of Columbia

The Special Review Committee disclosed not only the details of foreign payments previously disclosed but made public the existence of a "gray fund" for giving tips and presents to "relatively low-level governmental personnel" with whom Gulf had contact in South Korea and a "fondo nero," or black fund in Italy, out of which Gulf paid \$10,815 to newspapers, editors and journalists.

10-Month Investigation

The 298-page report, with six appendices, is the result of a 10-month inquiry headed by John J. McCloy, a senior part-ner of the New York law firm of Milbank, Tweed, Hadley & McCloy.
