Connally Rebuts Manchester; Plans Own Version

AUSTIN, Tex., Jan. 10-Gov. John B. Connally Jr. said today that President Kennedy visited Texas in 1963 only to restore his waning popularity.

He called it "common knowl-edge" that the trip during which the President was slain was of his "own making" and that it was "planned in the wake of polls reflecting declining popu-larity."

The Governor, speaking at a nnws conference, also said that he and his wife "would assemble and present the facts and de-tails as we know them relating to President Kennedy's visit." In the first installment of "The Death of a President," which appeared today in Look magazine, William Manchester says that Mr. Kennedy visited Texas to help the state's Demo-crats settle intra party disputes. In particular, Mr. Manchester says that Mr. Connally, a con-servative, was conducting a po-litical vendetta against Senator Ralph W. Yarborough, a lib-eral.

A Tense, chear Voice

Mr. Connally read his remarks in a tense, clear voice. He open-ed the news conference by an-nouncing that he would read the statement and have nothing "For more than three years,

"For more than three years, Mrs. Connally and I have sought to close the door on the memories of Nov. 22; 1963. We have resisted repeated efforts to enlist our assistance in the airing of more details of the trip and the tragedy. The in-tensity of our personal feeling and sense of helplessness as participants left deep emo-tional scars which we felt were the best borne in silence.

the best borne in silence. "Regretfully, we have con-cluded that we no longer have that choice in view of recent developments.

"The first published install-ment of the book "The Death of a President," represented as an 'authorized and authentic his-tory,' turns out to be an astontory,' turns out to be an aston-ishing propaganda instrument cleverly woven to reflect favor-ably on those who gave it birth, while rudely discrediting others involved. "It is filled with editorial comment based on unfounded numer distortion and incon-

rumor, distortion and incon-sistency. This transparent at-tempt to dictate history through a captive voice is shocking.

Discounted as Fact

"The privately commissioned author has contrived a presentaauthor has contriver a presenta-tion which undoubtedly, will achieve widespread readership. It cannot, however, qualify as factual history. It actually is a recitation of recollections and observations collected and reflected through the prisms of

"For example, it has been reported that President Ken-

nedy was unwillingly brought to Texas to settle a local political argument. To the to Texa political extent that there was any significant argument prior to the trip, it was between then Vice President Johnson and Senator Yarborough, both of whom were readily available in Washington.

ing planned in the wake of polls reflecting declining popularity. "I purposely have refrained from publishing any personal account of the details of the trip. However, in the interest of unmanaged history, I have reluctantly concluded that we have no choice but to assemble and present the facts and de-tails as we know them relating to President Kennedy's visit. These facts and details will be recorded in the hope that recorded in the hope that present-day writers and legiti-mate historians might find them useful in reaching objec-tive judgments."

Life Interview Recalled

Such an account would not be the first time the Governor has spoken about the assassination

for publication however. In November, Life magazine carried a lengthy interview with carried a lengthy interview with him in which he reviewed the films of the assassination taken by Abraham Zapruder, an amateur photographer in Dallas. Mr. Connally told Life he thought that he and President Kennedy had been hit by separate shots. The Warren Commission, which investigated the assassination, said that one of the bullets that struck the President also struck Mr. Connally. Connally.

Although the Governor said the day after Life appeared that ine day after Life appeared that a new investigation was "neither warranted, justified or desirable," the interview prompted Life to call for a reopening of the Warren Com-mission's investigation.

Tower Tells of Threats

WASHINGTON, Jan. 10 (AP)—Senator John G. Tower 10 disclosed today that a dummy bomb had been sent to his office by mail after the Kennedy assassination by someone evidently believing political conservatives were responsible for the

slaying. The Texas Republican made the disclosure in denouncing Mr. Manchester's portrayal of Mr. Manchester's portrayal of Dallas as a city permeated with hate.
