NEW YORK, JAN. 15 (AP)-LOOK MAGAZINE, KENNEDY FAMILY REPRESENTATIVES AND WEST GERMAN LAWYERS FOR BOTH DISCUSSED DETAILS TODAY OF A LAWSUIT AGAINST DER STERN--THE WEST GERMAN MAGAZINE THAT INSISTS ON PUBLISHING "THE DEATH OF A PRESIDENT" WITHOUT THE DELETIONS REQUESTED BY MRS. JOHN F. KENNEDY.

A SPOKESMAN FOR LOOK, WHICH IS SERIALIZING WILLIAM MANCHESTER'S ACCOUNT OF PRESIDENT KENNEDY'S ASSASSINATION, SAID "I EXPECT THEY WERE TALKING ABOUT THE NATURE AND THE TIMING OF THE SUIT."

PRESENT AT THE MEETING AT THE OFFICE OF SIMON H. RIFKIND, ATTORNEY FOR MRS. KENNEDY, WERE LOOK COUNSEL JOHN F. HARDING, THE GERMAN LAWYERS, AND KENNEDY FAMILY REPRESENTATIVES RICHARD GOODWIN AND EDWARD COSTIKYAN.

GOODWIN SAID LAWYERS FOR MANCHESTER AND HARPER & ROW, PUBLISHER OF THE BOOK VERSION, WERE ALSO TO TAKE PART.

THE GERMAN MAGAZINE PLANNED TO PUBLISH A SECOND INSTALLMENT OF THE ACCOUNT MONDAY. THE EPISODES WOULD BE ROUGHLY EQUIVALENT TO THE SECOND HALF OF LOOK'S FIRST INSTALLMENT WHICH APPEARED HERE JAN. 10.

"THIS ISSUE WON'T BE TOO DAMAGING," THE LOOK SPOKESMAN SAID. "IT'S WHAT DER STERN WILL PUBLISH NEXT WEEK THAT WE WANT STOPPED."

WILLIAM VANDEN HEUVEL, A KENNEDY FAMILY REPRESENTATIVE, SAID SATURDAY THAT HE HAD UNSUCCESSFULLY TRIED TO PERSUADE HENRI NANNEN, PUBLISHER OF DER STERN, TO MAKE THE SAME DELETIONS IN THE ORIGINAL MANUSCRIPT THAT LOOK IS MAKING.

THE DELETIONS, VANDEN HEUVEL SAID ON HIS RETURN FROM HAMBURG, RELATE ONLY TO EPISODES MRS. KENNEDY CONSIDERS TOO PERSONAL FOR PUBLICATION.

"NO DECENT PERSON WOULD WANT TO TRANSGRESS IN THE SORROW OF MRS. KENNEDY. THERE ARE NOT NOW AND THERE NEVER WAS, IN ANY OF OUR DISCUSSIONS AND SUGGESTIONS, CUTS OR CHANGES THAT HAVE ANY POLITICAL IMPLICATION REGARDING SEN. ROBERT KENNEDY," HE SAID.
