NEW YORK, JAN. 18 (AP)-LOOK MAGAZINE ANNOUNCED TODAY THAT IT HAS BROUGHT SEPARATE LAW SUITS AGAINST THE CHICAGO DAILY NEWS AND THE GERMAN MAGAZINE STERN OVER THE BOOK, "THE DEATH OF A PRESIDENT."

IN A STATEMENT, LOOK ACCUSED THE DAILY NEWS OF BREAKING AN EMBARGO ON PUBLISHING MATERIAL FROM THE SERIALIZATION OF THE BOOK. STERN, WHICH BOUGHT GERMAN SERIALIZATION RIGHTS FROM LOOK, HAS REFUSED TO MAKE DELETIONS REQUESTED BY MRS. JOHN F. KENNEDY AND CONCURRED IN BY LOOK.

LOOK, WITH THE BOOK'S AUTHOR, WILLIAM MANCHESTER AS CO-PLAINTIFF, CHARGED THE DAILY NEWS IN A FEDERAL COURT COMPLAINT IN CHICAGO WITH "UNFAIR COMPETITION; INFRINGEMENT OF COPYRIGHT; AND DELIBERATE IMPAIRMENT OF RIGHTS OF CONTRACT.

LOOK SOUGHT AN ACCOUNTING OF ANY PROFITS MADE BY THE DAILY NEWS THROUGH ITS PUBLICATION OF EXCERPTS FROM THE MAGAZINE SERIALIZATION, AND FOR DAMAGES LOOK SAID IT SUFFERED.

THE CHICAGO COMPLAINT ALLEGED THAT SUCH DAMAGES WERE IN EXCESS

OF \$200,000-MORE THAN \$100,000 FROM DILUTION OF THE VALUE OF THE

CONTRACT BETWEEN MANCHESTER AND LOOK, AND \$100,000 UPWARD FROM BUSINESS

LOSS RESULTING FROM "UNFAIR COMPETITION."

THE SUIT ALSO ASKED THAT THE DAILY NEWS BE BARRED BY COURT ORDER FROM REPRODUCING ANY PORTION OF THE MAGAZINE INCLUDING ITS COVER WITHOUT PERMISSION OF LOOK.

WHAT IT DESCRIBED AS THE PREMATURE PUBLICATION BY THE DAILY NEWS, LOOK SAID, FORCED A REVISION IN WHOLESALE AND RETAIL DISTRIBUTION PLANS OF THE MAGAZINE AND "DISRUPTED PLANS OF MANY NEWSPAPERS AND BROADCASTERS WHO HAD ACTED IN GOOD FAITH AND WITHHELD PUBLICATION OF MATERIAL FROM THE MANCHESTER SERIALIZATION UNTIL THE STIPULATED RELEASE TIME AND HAD CONFINED THEIR MARRATIVE TO THE AUTHORIZED."

LOOK SAID THE PURPORTED PREMATURE PUBATION INTERFERED WITH
ITS CONTRACTS WITH PUBLISHERS IN 25 OTHER COUNTRIES FOR COORDINATED
PUBLICATION OF THE SERIALIZATION.

"STERN IS THE ONLY PUBLICATION WHICH HAS REFUSED TO MODIFY THOSE PARAGRAPHS OF A PERSONAL NATURE WHICH DISTRESS MRS. KENNEDY. STERN SAYS THESE PASSAGES SHOULDN'T DISTRESS HER.
