OSWALD FPCC 544 Camp St.

WR 408/1: "While the legend 'FPCC 544 Camp St. New Orleans, La.' was stamped on some literature that Oswald had in his possession at the time of his arrest in New Orleans, extensive investigation was not able to connect Oswald with that address, although it did develop the fact that an anti-Castro organization had maintained offices there for a period ending early in 1962." \*

New Orleans Police arrest report says Oswald was passing "circulars" (9 Aug. 63); report of Maj. Presly J. Trosclair (12 Aug 63) describes the material as "communist literature." Following his report are reproductions of two "Hands Off Cuba" leaflets, one stamped A.J. Hidell, P.O. Box 30016, and the other L.H. Oswald, 4907 ~~4907~~ Magazine, and a reproduction of what appears to be a one-page circular printed by FPCC, New York. The last shows no local address. The exhibit does not include any material with the 544 Camp Street address.

A 39-page booklet, "The Crime Against Cuba" by Corliss Lamont, is stamped on last page "FPCC 544 Camp St. New Orleans, La." This is described in Contents, Vol. XXVI, as "Pamphlet entitled 'The Crime Against Cuba,' by Corliss Lamont (CD 1495a, pp. 1-39)." with no indication where and when it was obtained.

FBI SA John Quigley says in his report (15 Aug 63) that when he interviewed Oswald after his arrest he had in his possession and "made available" a copy of the Lamont booklet; if it also carried the Camp Street address there is no mention of it.

\*544 Camp Street was the address of the Cuban Revolutionary Council, and the same address, since it was a corner building, as that of Guy Banister, 531 Lafayette Street. See Weisberg, Oswald in New Orleans, p.331; Weisberg press conference, 13 Nov 67, filed Garrison.
