If alien registration cards are renewed yearly, this date seems reasonable. The Oswalds arrived in New York June 13, 1962.

Renewal of Marina's visa by U.S. Embassy, Moscow, "to June 24, 1962".

OSWALD (diary)

Passport:

CE 24 (p. 96) and CE 101, entries for Oct. 31, 1959 describing visit to Embassy to dissolve citizenship, are not the same. Is CE 101 Oswald's re-working of that page of CE 24?

CE 24 (p. 103), on intv. at Embassy about return of passport, July 8, a Saturday. Richard E. Snyder, with whom he spoke, told him to return Monday. No details of later interview or interviews, or Marina's visit to Embassy. Notation "see July 8 - 13" may have covered this but not included. Oswalds returned to Minsk July 14.

CE 24 (p. 103). "July 8. Interview July 9 receive passport ..."  
Snyder testified passport returned to Oswald July 10. Monday.  
Mistake in dating by Oswald? No entry for Sunday, July 9.

Dulles: Could that be read into the record - just what did he say about the handling of the passport at that time - that is July what?

Snyder: July 8, 1961. This was July 8. "Oswald intends to institute an application" --

Coleman: Pardon me. Wasn't it really July 10? July 8 was the day he came over to the Embassy just for a few moments. Then he came back on the 10th.

Snyder: I don't know. It isn't clear from my despatch, I would say.
