BUFFALO, N.Y., FEB. 28 (AP)-THE CASE AGAINST LEE HARVEY OSWALD, ACCUSED ASSASSIN OF PRESIDENT JOHN F. KENNEDY, IS FRAUGHT WITH "CONTRADICTION, INCONSISTENCIES AND FALSEHOODS," A NEW YORK ATTORNEY REPRESENTING OSWALD'S MOTHER MAINTAINS.

MARK LANE TOLD A STUDENT GROUP LAST NIGHT THAT HE HAD EVIDENCE THAT OSWALD MIGHT NOT BE THE KILLER. HE SAID HE WOULD PRESENT IT TO THE WARREN COMMISSION WHICH IS INVESTIGATING THE NOV. 22 ASSASSINATION AND SUBSEQUENT EVENTS.

LANE SAID, HOWEVER, HE FELT THE COMMISSION WAS CONDUCTING THE INVESTIGATION ON A FALSE PREMISE: THAT, IN FACT, OSWALD WAS THE SLAYER. HE SAID THE COMMISSION SHOULD INSTEAD BE ATTEMPTING TO AS-CERTAIN WHO ACTUALLY KILLED THE PRESIDENT.

LANE, SCHEDULED TO SPEAK TO THE GROUP IN THE HOTEL BUFFALO, SPOKE INSTEAD AT A CHURCH AFTER JUSTICE MATTHEW J. JASEN OF STATE SUPREME COURT DECIDED HE COULD NOT USE THE HOTEL FACILITIES.

HOTEL OFFICIALS SAID IN CANCELLING THE RESERVATION THEY HAD RECEIVED TELEPHONE CALLS FROM ORGANIZATIONS THREATENING TO PICKET IF LANE APPEARED. THEY SAID SUCH THREATS CONSTITUTED A DANGE TO HOTEL PROPERTY AND GUESTS.

JASEN CONTENDED THE CASE WAS "A CIVIL MATTER" BETWEEN THE COMMITTEE TO HEAR MARK LANE (CAP~C, H, M, L) AND THE HOTEL. "THIS IS NOT A QUESTION OF WHETHER MR. LANE HAS A RIGHT TO BE HEARD; HE HAS SUCH A RIGHT, BUT IT IS A QUESTION OF WHERE," JASEN SAID.

THE COMMITTEE IS COMPRISED OF STUDENTS FROM THE STATE UNIVERSITY OF NEW YORK AT BUFFALO AND THE STATE UNIVERSITY COLLEGE AT BUFFALO.
