## **Defense Claims Thoresen** as Slain While Awake

Attorneys defending Louise Thoresen on murder charges presented a strong case yesterday that William E. Thoresen III was awake-and hallucinating — when she shot hmi to death.

The prosecution has contended that IMrs. IThoresen did not act n self defense when she fired ive bullets into he gun czar's back as he lay on a bed.

Diana McDermott, a friend and a neighbor ,had estified that Mrs. Thoresen said she "s h'o Bill when he was asleep" moments after the June 10 killing.

**OBJECTIONS** 

In attacking the prosecution's case, defense attorneys Kenneth DeVaney and James Sheperd:

• Introduced, over strong prosecution objections, t e testimony of three Fresno o-

li men who interviewed Mrs. McDermott after the killing and said she never told them about Mrs. Thoresen's alleged statement.

 Put a psychiatrist who is an expert on LSD on the stand o testify hat Thoresen, whose blood showd traces of LSD, "was decided-ly aw ke" when he was killed and, based upon a history of Thoresen's tormented personality, probably was on a massive bummer when he died.

g - Introduced into evidence the testimony of a former business ssociate who said the gun collecting millionaire had told him he wanted to die preferably in a violent manner.

Throughout the 11 days of trial, Mrs. Thoreen has maintained she shot her husband because she believed her life was in immediate danger; that oments efore she pulled the trigger her husband had said, "I can't let you leave no w you know too much."

The three policemen ho testiifed said they had collec-

tively the neighborhood of n ne hours talking to Mrs. mcDermott.

## 'REMEMBERED'

De tective Perry Foster said he would "definitely have re membered" if Mrs. McDermott had told him Mrs. Thore sen said she shot her husband while he was as

leep. "It would have been an improvement to the case," the investigator said.

Unde r cross examiniation, Foster said, "I was just led to be lieve he was asleep nobody mentioned that he was asleep or that he had attacked anybody."

Mrs. Thoresen testified her husband repeatedly beat her several hours before she killed him.

Two other officers - Donald Watson and Alvin Myers also testified Mrs. McDermott said nothingto them indicating Thoresen was asleep when he died.

SUBJECTS

Dr. KeithDitman, a Bever-

spent somewhere in ly Hills psychiatrist, who heighborhood of nne said he has administered LSD to some 500 subjects, testified that on the basis of laboratory reports, the gun dzar could havetaken a dose of some 150 mecrograms of LSD several hours beforehe died.

> A quantity of barbiturates was also foundin Thore sen's blood and Ditman said that while the combination might have acted as a slight seda-tive what he knew about Thoresen indicated the effects could have "led to a psychotic break. . . .'

Charles Malcolm, a Los Angeles businessmen who said he once attempted suicide with sleeping pills, testified that in late May Thoresen, who knew of Malcolm's suicide attempt, asked him for what amounted to expert advice on the subject.

"He was extremely de-pressed," Malcolm said of Thoresen.

"He said he was of no service to himself and he wanted to die."
