## Countries Weigh Trial of Cubans

WASHINGTON, Oct. 20sentatives of five Caribbean governments met in Port of Spain, Trinidad, today to determine where a group of Cuban exiles accused of causing a plane crash fatal to 73 persons should be tried.

The United States Government, which has laid jurisdictional claim to one of the suspects, Orlando Bosch, was not invited to participate, State Department officials reported.

Nor has Venezuela responded to a request for the return of Mr. Bosch, who is wanted here for a parole violation and is now in detention in Caracas with 13 others suspected of involvement in a series of terrorist actions in this country and elsewhere in the hemisphere

and elsewhere in the hemisphere.

Mr. Bosch, 49 years old, has said he is a leader of the Commandos of the United Revolutionary Organizations, an umbrella organization made up of five Cuban exile groups.

He left the United States two years ago after serving part of a 1968 sentence for anti-Castro terrorist activities in Miami. He has since been reported by United States authorities to have turned up in Chile, Nicaragua, the Dominican Republic, Curacao and Venezuela.

Mr. Bosch and his fellow suspects in Caracas have been linked by Venezuelan authorities to a bomb plot carried out Oct. 6 against a Cuban airliner that crashed off Barbados, and to the bomb slaying Sept. 21 of Orlando Letelier, former Foreign Minister of Chile, in Wash-

Another Cuban exile, Hernán Richardo Losano, has confessed to the authorities

-Legal repre-, ations said in a telephone interview that Guyana was insisting that Barbados try the two suspects under arrest in Trinidad, arguing that the plane crashed nearest Barbados. Barbados has rejected this claim, arguing that the explosion took place over international waters.

Venezuela, which is represented in Port of Spain by the Acting Interior Minister, March Tullio Brunicelli, has vowed to bring the perpetrators of the airline crash

to justice.

But Venezuelan officials said today that the case had become embarrassing to the Caracas Government because some of the Cuban exiles under arrest held high positions in the Government of President Carlos Andrés Pérez. These officials also said that President Pérez had maintained contact with the Chilean military leadership through the Cuban exiles

Two of the exiles under arrest in Cara-Cas were trained by the United States Central Intelligence Agency and used in actions against the Government of Prime Minister Fidel Castro after 1960, other Cuban exiles and Administration officials said today.
