DALLAS, MARCH 10 (AP)-MRS. MARGUERITE OSWALD VISITED TODAY THE TEXAS SCHOOL BOOK DEPOSITORY FROM WHERE, POLICE SAY, HER SON FIRED THE SHOTS THAT KILLED PRESIDENT KENNEDY.

SHE DID NOT GO TO THE SIXTH FLOOR, SHE SAID. AUTHORITIES SAY LEE HARVEY OSWALD STOOD AT A WINDOW ON THAT FLOOR TO FIRE HIS RIFLE NOV. 22.

SHE CALLED THE VISIT TO THE BUILDING A "PERSONAL INVESTIGATION."

"I'M DOING THIS INVESTIGATION AND IT'S STRICTLY ON MY OWN," THE 56-YEAR-OLD FORT WORTH, TEX., WOMAN SAID.

SHE SAID SHE WOULD NOT COMMENT ON RESULTS OF HER INVESTIGATION, ADDING: "IF I SOLVE THIS CASE, THEN I WILL TELL YOU BOYS."

A SOURCE INSIDE THE DEPOSITORY SAID MRS. OSWALD ASKED WHETHER HER SON WAS WORKING THE DAY KENNEDY WAS KILLED AND ABOUT THE CLOTHES HE WORE.

DALLAS, MARCH 10 (AP)-MRS. MARGUERITE OSWALD, MOTHER OF THE ACCUSED ASSASSIN OF PRESIDENT KENNEDY, WENT TODAY INTO THE TEXAS SCHOOL BOOK DEPOSITORY FROM WHERE, POLICE SAY, KENNEDY WAS SHOT.

THE BUILDING WAS LOCKED AFTER SHE ENTERED AND NO ONE ELSE WAS PERMITTED ENTRY.

REASON FOR HER GOING TO THE BUILDING WAS NOT IMMEDIATELY APPARENT. SHE HAS SAID SHE IS INVESTIGATING THE ASSASSINATION PERSONALLY AND BELIEVES HER SON, LEE HARVEY OSWALD, IS INNOCENT.

POLICE SAID OSWALD STOOD AT A SIXTH FLOOR WINDOW AND SHOT THE PRESIDENT NOV. 22 DURING A DOWNTOWN MOTORCADE.

THE BUILDING IS DIAGNOALLY ACROSS THE STREET FROM WHERE JACK RUBY IS ON TRIAL FOR MURDER FOR SLAYING OSWALD.

MRS. OSWALD TRIED TO ENTER THE RUBY TRIAL COURTROOM TODAY BUT WAS THWARTED WHEN PROSECUTORS SUBPOENAED HER AS A WITNESS, MEANING SHE MUST REMAIN OUTSIDE THE COURTROOM UNLESS CALLED TO TESTIFY.
