MRS. OSWALD (450)

SAN ANTONIO, TEX., DEC. 1 (AP)--PROVE HIM GUILTY OR INNOCENT, SAYS MARGUERITE OSWALD OF HER SON--LEE HARVEY OSWALD--WHO STANDS OFFICIALLY ACCUSED OF THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

"I AM GRATEFUL TO THE MEN OF THE COMMISSION," SAID SAID IN DISCUSSING THE WARREN COMMISSION REPORT, "BUT I KNOW THEY MADE ERRORS, ERRORS BEYOND THEIR CONTROL. . . ."

"ADMITTEDLY, THERE WAS CIRCUMSTANTIAL EVIDENCE, BUT THERE WAS NO PROOF. I WANT HIM PROVED INNOCENT OR GUILTY, AND TO HELP THAT CAUSE I WOULD EVEN PROVE HIM GUILTY."

MRS. OSWALD ALSO SAID IN RADIO AND TELEVISION INTERVIEWS HERE YESTERDAY "THAT LEE DID NOT KILL (DALLAS POLICEMAN) J. D. TIPPIT. . . ."

~~"I BELIEVE THAT TIPPIT IS THE CLUE. I BELIEVE THAT IF WE BREAK THE TIPPIT KILLING, WE'LL HAVE THE KEY."~~ SHE DID NOT ELABORATE.

IN AN INTERVIEW ON WOAI-TV, MRS. OSWALD SAID SHE ALSO WANTS THE WARREN REPORT TO CALL HER SON THE "ALLEGED ASSASSIN" INSTEAD OF THE "ASSASSIN" BECAUSE HE DIED A LEGALLY INNOCENT MAN "UNDER TEXAS LAW AND THE CONSTITUTION . . . ."

~~"HE COULD HAVE KILLED THE PRESIDENT,"~~ THE FORT WORTH WOMAN SAID. ~~"(BUT) IF HE'S GUILTY, I WANT HIM PROVED GUILTY."~~

SHE REPEATED A CHARGE SHE MADE EARLIER IN THE DAY ON WOAI RADIO THAT HER SON WAS "A PATSY", OR FRAMED, IN THE PRESIDENT'S DEATH.

MRS. OSWALD SAID SHE HAS HAD TO SELL ITEMS THAT BELONGED TO OSWALD IN ORDER TO KEEP UP HER "INVESTIGATION" OF THE ASSASSINATION.

ASKED WHERE SHE GOT THE MONEY FOR HER INVESTIGATION, SHE SAID SHE HAS RECEIVED \$1,300 IN DONATIONS, HAD A \$900 INSURANCE POLICY ON OSWALD, "SOLD THE USE OF MY SON'S PICTURES," SOLD 16 LETTERS HE WROTE AND "AUCTIONED OFF ITEMS AT GREAT PAIN IN ORDER TO LIVE IN 1965." SHE SAID THE AUCTION NETTED "FIVE THOUSAND AND SOME ODD DOLLARS."

THE FORT WORTH WOMAN SAID SHE HAS SPOKEN FOR HER CAUSE A NUMBER OF TIMES AT DIFFERENT PLACES IN THE COUNTRY, ALWAYS BEFORE PAYING HER OWN WAY AND AT "GREAT EMOTIONAL EXPENSE." SHE SAID SHE IS "STARTING NOW TO ASK REIMBURSEMENT" FOR SUCH APPEARANCES. MRS. OSWALD'S EXPENSES FOR HER APPEARANCE HERE WERE PAID BY WOAI RADIO AND TELEVISION.

DURING THE TELEVISION INTERVIEW, THE PLUMP, BESPECTACLED, GRAY-HAIRED WOMAN PRESENTED A PICTURE TAKEN OF THE KENNEDY CAR JUST BEFORE THE PRESIDENT WAS SHOT IN DALLAS. SHE SAID A MAN IN THE BACKGROUND LOOKS LIKE HER SON AND ANOTHER MAN IN THE PICTURE "LOOKS VERY MUCH LIKE JACK RUBY." THE WARREN REPORT PLACES BOTH MEN AT DIFFERENT LOCATIONS AT THE TIME OF THE ASSASSINATION.

DURING THE RADIO INTERVIEW, MRS. OSWALD SAID SHE BELIEVES HER SON WAS SENT TO RUSSIA IN 1960 AS A SPY. SHE SAID HE WAS PROCESSED FOR A "DIRE NEED" DISCHARGED FROM THE MARINE CORPS AT THE SAME TIME HIS PASSPORT APPLICATION WAS BEING PROCESSED.

SHE SAID THIS PROVES "THAT MY SON WENT TO RUSSIA WITH THE FULL KNOWLEDGE OF THE MARINE CORPS AND MY GOVERNMENT."

EARLIER, MRS. OSWALD TOLD A NEWSMAN SHE SOLD ENOUGH OF OSWALD'S LETTERS "TO EAT AND JUST ENOUGH TO CONTINUE THIS FIGHT TO CLEAR MY SON'S NAME. I CERTAINLY HAVE DONE NOTHING TO BE ASHAMED OF. THE FACT IS, I AM PRETTY PROUD OF WHAT I HAVE ACCOMPLISHED ON THE LIMITED FUNDS I HAVE HAD TO WORK WITH."
