SECOND NIGHT LEAD OSWALDS

FORT WORTH, TEX. JAN.27 (AP)-MRS. ARGUERITE OSWALD SAID TONIGHT
THAT HER DAUGHTER-IN-LAW'S STATEMENT THAT LEE HARVEY OSWALD KILLED
PRESIDENT KENNEDY SHOWS "MARINA HAS BEEN IN SECLUSION TOO LONG."

SHE REFERRED TO A TELEVISION INTERVIEW IN WHICH MARINA OSWALD,
22-YEAR-OLD RUSSIAN-BORN BLONDE, SAID "I DON'T WANT TO BELIEVE...BUT
I HAVE TOO MUCH FACTS, AND FACTS TELL ME THAT LEE SHOT KENNEDY."

THE EXCLUSIVE, COPYRIGHTED INTERVIEW WITH STATION KRLD AM-FM-TV, OF DALLAS, WAS THE FIRST FOR MARINA SINCE THE FUNERAL FOR HER HUSBAND, ACCUSED PRESIDENTIAL ASSASSIN WHO WAS SHOT TO DEATH IN THE DALLAS CITY JAIL NOV.24 BY NIGHT CLUB OPERATOR JACK RUBY. SHE HAS BEEN IN THE PROTECTIVE CUSTODY OF SECRET SERVICE AGENTS FOR THE PAST TWO MONTHS.

"WHERE DOES SHE GET THESE FACTS? WHO HAS BEEN TALKING TO MARINA?"

I KNOW THAT I HAVE NOT BEEN ALLOWED TO TALK TO HER AND I KNOW MANY

OTHER PERSONS WHO HAVE NOT BEEN ALLOWED TO TALK TO HER, "THE ELDER MRS.

OSWALD SAID TONIGHT IN AN INTERVIEW WITH STATION KBOX OF DALLAS.

"FOR A LONG TIME I HAVE BELIEVED THAT A PROFOUND EFFORT HAS BEEN MADE TO CHANGE HER BELIEF IN LEE'S INNOCENCE," THE MOTHER SAID.

MRS. OSWALD SAID THAT IT IS HER BELIEF THAT ALL "THE FACTS" TO WHICH HER DAUGHTER-IN-LAW BASED HER CONCLUSION AS TO HER RUSBAND'S GUILT CAME FROM SECRET SERVICE AGENTS.

"I FEEL SORRY FOR THIS GIRL," MRS. OSWALD SAID. "BUT I THINK MARINA HAS BEEN IN SECLUSION TOO LONG."

MRS. OSWALD, 56, WAS ALSO CRITICAL OF AN ANNOUNCEMENT FROM WASHINGTON THAT HER ATTORNEY WILL NOT BE ALLOWED TO CROSS-EXAMINE WITNESSES DURING A PRESIDENTIAL COMMISSION INVESTIGATION OF KENNEDY'S ASSASSINATION.

MARINA OSWALD IS DUE TO BE THE FIRST WITNESSES CALLED AT THE HEARING.

THE ELDER MRS. OSWALD SAID TONIGHT THAT HER DAUGHTER-IN-LAW SHOULD BE CROSS-EXAMINED AT THE HEARING.

"MY SON HAS NOT HAD THE OPPORTUNITY TO BE ABLE TO PROVE HIS INNOCENCE AND HE WILL ALWAYS BE THE ACCUSED," MRS. OSWALD SAID. "THIS THING HAS NOT BEEN HANDLED PROPERLY, IT HAS NOT BEEN HANDLED IN THE AMERICAN WAY."

MRS. OSWALD HAS BEEN SEPARATED FROM HER DAUGHTER-IN-LAW FOR MORE THAN TWO MONTHS.

EARLIER TODAY, THE ELDER MRS. OSWALD SAID SHE SAW MARINA AT THE GRAVESIDE OF HER SON YESTERDAY BUT SECRET SERVICE MEN PREVENTED THEM FROM SPEAKING.

"SECRET SERVICE AGENTS WHISKED MY DAUGHTER-IN-LAW AWAY THE MINUTE THEY SPOTTED ME," THE MOTHER DECLARED.

"SHE DIDN'T HAVE A CHANCE TO SAY ANYTHING TO ME."

MRS. OSWALD, 56, AND HER DAUGHTER-IN-LAW, MARINA, 22, HAVE BEEN SEPARATED SINCE SHORTLY AFTER OSWALD WAS KILLED NOV. 24 BY DALLAS NIGHTCLUB OPERATOR JACK RUBY.

MRS. OSWALD HAS CHARGED REPEATEDLY THAT FEDERAL AGENTS HAVE IGNORED HER REQUESTS TO TALK WITH MARINA. THE SECRET SERVICE HAS KEPT THE WIDOW AND HER TWO YOUNG DAUGHTERS IN SECLUSION SINCE HER HUSBAND'S DEATH.

THE MOTHER ALSO HAS QUESTIONED STATEMENTS ATTRIBUTED TO MARINA THAT MARINA ACCEPTS THE VIEWPOINT OF POLICE THAT HER HUSBAND KILLED KENNEDY.

OF THE INCIDENT YESTERDAY, SHE SAID:

"THEY HAD NO RIGHT KEEPING ME FROM SPEAKING TO MY DAUGHTER-IN-LAW AND GRANDDAUGHTER."

ACCORDING TO THE MOTHER, THIS IS WHAT OCCURRED:

MARINA AND HER OLDEST DAUGHTER, JUNE, 2, WERE ALREADY AT THE GRAVE, AT ROSE HILL CEMETERY. MRS. OSWALD DROVE UP THE WINDING CEMETERY ROAD TOWARD THE GRAVE ABOUT 1 P. M.

MRS. MARINA OSWALD AND HER CHILD THEN GOT IN A CAR WITH SEVERAL MEN. BY NOW MRS. MARGUERITE OSWALD HAD REACHED THE GRAVE AND WAS GETTING OUT OF HER CAR WITH A POT PLANT.

SHE STOOD IN FRONT OF A SECOND CAR IN WHICH THERE WERE SEVERAL MEN.

AS SOON AS SHE STEPPED OUT OF THE WAY, THIS CAR SPED OFF IN THE SAME DIRECTION AS THE CAR CONTAINING MARINA AND HER CHILD.
