Q. MRS. OSWALD, DID YOUR HUSBAND EVER SAY ANYTHING TO YOU THAT WOULD LEAD YOU TO THINK THAT HE MIGHT HAVE BEEN ANGRY WITH PRESIDENT KENNEDY?

A. NO, HE NEVER DID SAY ANYTHING.

Q. DO YOU KNOW WHAT HE THOUGHT OF THE PRESIDENT? DID HE EVER SAY HOW HE FELT ABOUT HIM?

A. I THINK ..... NO, HE NEVER DON'T SAY ANYTHING BAD ABOUT PRESIDENT.

Q. DID YOUR HUSBAND EVER MENTION TO YOU GOING TO MEXICO?

A. YES...IN NEW ORLEANS...IN SEPTEMBER.

Q. DO YOU KNOW WHY HE WENT TO MEXICO?

A. HE WANT TO GO TO LIVE IN CUBA.

Q. DID HE SAY WHY HE WANTED TO GO AND LIVE IN CUBA?

A. YES, THIS IS INTEREST FOR HIM.
