IN A COPYRIGHTED STORY BY THE DALLAS MORNING NEWS, THE WIDOW OF PRESIDENT KENNEDY'S ACCUSED ASSASSIN SAID SHE DOES NOT BELIEVE IN CAPITAL PUNISHMENT.

"WHEN THERE IS NO WAR ON, NO HUMAN BEING HAS THE RIGHT TO TAKE ANOTHER'S LIFE," MARINA SAID.

SHE SAID SHE HAD READ SOME AND WATCHED TELEVISION NEWS CONCERNING THE MURDER TRIAL OF RUBY NOW UNDERWAY HERE, "BUT I'M NOT FOLLOWING IT ALL THE WAY. I'M JUST INTERESTED."

SPEAKING IN RUSSIAN THROUGH AN INTERPRETER OR IN BROKE ENGLISH, MARINA SAID SHE HOPED TO SOMEDAY "TO SOMETHING FOR AMERICA IN RETURN FOR THE WONDERFUL TREATMENT I'VE RECEIVED."

SHE SAID "I THINK HOW VERY FORTUNATE I AM TO HAVE BEEN TREATED SO WONDERFULLY BY THE AMERICAN PEOPLE. SO MANY WIDOWS LOSE THEIR HUSBANDS AND MUST RAISE THEIR CHILDREN WITH NO HELP AT ALL, NOT EVEN A KIND WORD. I CERTAINLY WAS SURPRISED. I DIDN'T EXPECT IT THIS WAY."

SINCE THE NOV. 22 ASSASSINATION, AN ESTIMATED \$68,000 HAS BEEN CONTRIBUTED TO THE RURRIAN BORN MARINA. SHE

CONTRIBUTED TO THE RUSSIAN BORN MARINA. SHE SAID THE MONEY IS UNDER "COMPLETE CONTROL" OF JAMES MARTIN AND JOHN THORNE, HER BUSINESS ADVISOR AND LAWYER HIRED WHILE SHE WAS IN PROTECTIVE CUSTODY. THEY SAID THE CONTRIBUTIONS WERE BEING HELD IN TRUST FOR MARINA AND HER CHILDREN BUT SHE COULDN'T DRAW ANY OF THE MONEY WITHOUT THEIR SIGNATURES.
