DALLAS, TEX.AUG.18 (AP)-SHERIFF'S OFFICERS TONIGHT JAILED THE 27-YEAR-OLD HUSBAND OF MARINA OSWALD PORTER AFTER SHE SAID HE SLAPPED HER IN THE FACE AND FRIGHTENED HER WITH A GUN.

THE COUPLE WERE MARRIED LESS THAN THREE MONTHS AGO ..

MRS. PORTER, THE WIDOW OF LEE HARVEY OSWALD, THE MAN WHO ASSASSINATED PRESIDENT KENNEDY, ALSO SAID IN AN AFFIDAVIT THAT KENNETH JESS PORTER THREATENED TO KILL HIMSELF.

SHE SIGNED THE DOCUMENT LATE THIS AFTERNOON IN THE COURT OF JUSTICE OF THE PEACE W. E. RICHBURG, WHO THEN ISSUED A WARRANT FOR PORTER'S ARREST.

RICHBURG SAID THE PURPOSE OF THE AFFIDAVIT WAS TO PLACE PORTER UNDER A PEACE BOND. HE SAID THE ELECTRONICS FIRM EMPLOYE, WHO WAS MARRIED TO THE RUSSIAN-BORN WIDOW JUNE 1, WOULD REMAIN IN CUSTODY EITHER UNTIL HE MADE BOND OR UNTIL A HEARING ON THE ISSUE WERE HELD.

RICHBURG DID NOT INDICATE WHEN SUCH A HEARING MIGHT BE CONVENED.

MRS. PORTER, 23N APPEARED AT RICHBURG'S COURT WITH HER TWO
CHILDREN. AS SHE LEFT THE BUILDING, SHE SNAPPED *LEAVE ME ALONE,
PLEASE, * TO A GATHERING OF REPORTERS AND PHOTOGRAPHERS.

SNE AND HER CHILDREN ENTERED A CAR AND WERE DRIVEN AWAY BY A MAN AND .
WOMAN WHO SAID THEY WERE HER NEIGHBORS. THEY DECLINED TO GIVE THEIR
NAMES OR TO SAY WHERE MARINA WOULD SPEND THE NIGHT.

THE JUSTICE OF THE PEACE SAID SHERIFF'S OFFICERS CALLED HIM EARLIER IN THE AFTERNOON FROM THE PORTER HOME IN NORTHEAST DALLAS. HE SAID HE THEN TALKED WITH PORTER AND ASKED THE MAN TO COME TO HIS OFFICE "TO TALK THINGS OVER."

RICHBURG SAID PORTER REFUSED AND SAID, "GO AHEAD AND ISSUE A

TEXAS PEACE BONDS CUSTOMARILY PROHIBIT A MAN FROM VISITING OR BOTHERING A WOMAN.

THE FORMER MRS. OSWALD SIGNED THE AFFIDAVIT IN THE CITY-COUNTY BUILDING IN SUBURBAN OAK CLIFF, ONLY BLOCKS FROM THE MOVIE THEATER WHRE OSWALD WAS ARRESTED THE AFTERNOON OF NOV.22, 1963.

THE PORTERS MOVED FROM THE SUBURB OF RICHARDSON'INTO THE CITY OF DALLAS PROPER THIS SUMMER. THEY LIVE IN A HOUSE REPORTEDLY COSTING SOME \$26,000. RECORDS INDICATE THAT THE HOUSE IS IN THE NAME OF "MARINA OSWALD."

THE PEACE JUSTICE SAID PORTER WOULD BE LODGED IN THE DALLAS COUNTY JAIL, THE SAME JAIL WHERE JACK RUBY IS CONFINED UNDER DEATH SENTENCE FOR HIS KILLING OF OSWALD.
