THE SLAYER OF LEE HARVEY OSWALD, THE MAN ACCUSED OF ASSASSINATING PRESIDENT JOHN F. KENNEDY, ALSO UNDERWENT MENTAL TESTS YESTERDAY. SHERIFF BILL DECKER DECLINED TO SAY WHERE RUBY WAS TAKEN. HE

ALSO WOULD NOT SAY WHEN RUBY WOULD BE RETURNED.

RUBY APPEARED TO BE VERY CALM TODAY AND APOLOGIZED TO NEWSMEN FOR NOT ANSWERING THEIR QUESTIONS YESTERDAY AS HE WAS BEING RETURNED TO THE JAIL.

"YESTERDAY I WAS NERVOUS AND DIDN'T EXPCT YOU GUYS," HE SAID.
WHEN ASKED QUESTIONS, HE CONFERRED WITH DEFENSE LAWYERS AND
ANSWERED, "I BELIEVE EVERYTHING WILL COME OUT IN THE TRIAL."

AT A BOND HEARING LAST WEEK, A PSYCHIATRIST AND A PSYCHOLOGIST SAID THEY BELIEVE RUBY IS SUFFERING FROM ORGANIC BRAIN DAMAGE.

THE DEFENSE REQUESTED THAT TESTS BE MADE, AND WITHDREW THEIR PLEA FOR RUBY'S RELEASE ON BOND WHEN JUDGE JOE B. BROWN AGREED TO THE EXAMINATIONS.

BECAUSE PHYSICAL BRAIN DAMAGE DIFFERS FROM A MENTAL DISORDER
WHICH CAN BE DETERMINED BY PSYCHIATRIC EXAMINATIONS, SPECIAL EQUIPMENT
WAS NEEDED.

THIS REQUIRED THAT RUBY BE TAKEN TO WHERE FACILITIES WERE AVAILABLE.

JUDGE BROWN SAID EARLIER THAT THE PSYCHIATRISTS ASSIGNED TO TEST RUBY INDICATED ADDITIONAL TESTS BEYOND THOSE MADE YESTERDAY WOULD BE NECESSARY.

TRIAL IN DALLAS.
