ALLEN W. MCCOY, 39, INDUSTRIAL ENGINEER. FATHER OF TWO GIRLS. A BAPTIST. SERVED BEFORE AT A CIVIL TRIAL.

MRS. MILDRED MCCOLLUM, 40, SECRETARY TO A BUILDING CONTRACTOR AND MOTHER OF SIX CHILDREN. MEMBER OF THE ASSEMBLY OF GOD. IT WAS HER FIRST JURY SERVICE.
