SAN FRANCISCO, APRIL 27 (AP)-ATTORNEY MELIN BELLI TODAY ADVISED WALTER E. CRAIG, AMERICAN BAR ASSOCIATION PRESIDENT, THAT HE HAD DECIDED AGAINST RESIGNING QUIETLY FROM THE LAWYER ORGANIZATION.

"I'M GOING TO LET YOU TRY AND KICK ME OUT PUBLICLY," SAID BELLI WHO WAS DISMISSED AS DEFENSE COUNSEL AFTER JACK RUBY WAS CONVICTED IN DALLAS OF KILLING LEE HARVEY OSWALD, THE ACCUSED ASSASSIN OF PRESIDENT KENNEDY.

IN A 26-PAGE LETTER TO CRAIG, BELLI DEMANDED A PUBLIC HEARING OF CHARGES OF UNETHICAL CONDUCT AGAINST HIM FOLLOWING A COURTROOM OUTBURST AFTER THE DALLAS JURY RETURNED A DEATH VERDICT FOR RUBY.

BELLI PROPOSED THAT THE SAME HEARING CONSIDER CRAIG'S STATEMENTS TO A NEWS CONFERENCE IN SAM FRANCISCO THAT BELLI'S "INTEMPERATE AND ABUSIVE" REMARKS CONSTITUTED "UNETHICAL CONDUCT."

ON HIS RETURN FROM A BRIEF MEXICAN VACATION AFTER THE RUBY TRIAL BELLI TOLD A SAN FRANCISCO NEWS CONFERENCE THAT HE WAS RESIGNING FROM THE AMERICAN BAR ASSOCIATION BECAUSE OF CRAIG'S STATEMENT.

IN HIS LETTER BELLI TOLD CRAIG:

"AT THE TIME YOU PERSONALLY AND SO PUBLICLY CONVICTED WITHOUT DUE OR WNY PROCESS, YOU ACTED IN A MOST UNETHICAL MANNER, SIR, AND I SO CHARGE YOU."

BELLI CONTENDED CRAIG HAD NOT CONSULTED THE ASSOCIATION'S GRIEVANCE COMMITTEE AND HAD NO RIGHT TO SPEAK AS PRESIDENT OF THE ASSOCIATION IN CONDEMNING BELLI'S DALLAS COURTROOM CONDUCT.

BELLI NOTED THAT O.B. MCEWAN OF ORLANDO, FLA., CHAIRMAN OF THE ABA'S COMMITTEE OF PROFESSIONAL GRIEVANCES, HAD ANNOUNCED THAT "BELLI WILL BE GIVEN THE OPPORTUNITY TO APPEAR BEFORE THE COMMITTEE AND THAT THE COMMITTEE WILL REPORT ITS FINDINGS AND RECOMMENDATIONS TO THE ABA BOARD OF GOVERNORS."
