OSWALD-RUBY POSTAL BOXES (260)

DALLAS, JULY 6 (AP)-LEE HARVEY OSWALD AND JACK RUBY COULD HAVE SEEN EACH OTHER BY ACCIDENT BECAUSE OF THE PROXIMITY OF THEIR POST OFFICE BOXES, THE DALLAS TIMES HERALD SAID TODAY.

THE BOXES OF ACCUSED PRESIDENTIAL ASSASSIN OSWALD AND THE MAN WHO KILLED HIM WERE 12 FEET APART AT THE TERMINAL ANNEX POST OFFICE HERE.

HOWEVER, THERE IS NO EVIDENCE THAT THEY DID MEET.

OSWALD, ACCUSED OF SLAYING PRESIDENT JOHN F. KENNEDY NOV. 22, RENTED HIS BOX NOV. 1. RUBY RENTED HIS BOX NOV. 7.

BOTH MEN, THE TIMES HERALD SAID, PICKED UP MAIL IN THEIR BOXES. BOTH PARENT THROUGH THE QUARTER E

BOTH MEN, THE TIMES HERALD SAID, PICKED UP MAIL IN THEIR BOXES. BOTH PAID RENT THROUGH THE QUARTER ENDING DEC. 31. BOTH BOXES NOW HAVE BEEN RENTED TO OTHER PERSONS.

THE TERMINAL ANNEX BOD WAS NOT THE ONE AT WHICH OSWALD RECEIVED THE HIGH-POWERED RIFLE HE ALLEGEDLY USED TO FIRE THE BULLETS WHICH KILLED THE PRESIDENT AND WOUNDED GOV. JOHN CONNALLY OF TEXAS.

THAT BOX, RENTED UNDER THE NAME OF A. HIDELL, WAS AT THE MAIN POST OFFICE IN DOWNTOWN DALLAS.

RUBY LISTED "EARL PRODUCTS" IN THE BLACK ASKING "FIRM OR ORGANIZA-TION." UNDER TYPE OF BUSINESS HE LISTED "MERCHANDISING."

OSWALD LISTED THE FAIR PLAY FOR CUBA COMMITTEE AND THE AMERICAN CIVIL LIBERTIES UNION AS THE ORGANIZATIONS USING THE BOX. THE CIVIL LIBERTIES UNION HAS SAID THAT OSWALD HAD NO CONNECTION WITH IT OTHER THAN SENDING IN AN APPLICATION FOR MEMBERSHIP AND THE \$2 MEMBERSHIP FEE AND THAT THE BOX WAS NOT AN OFFICIAL ONE FOR THAT ORGANIZATION.

THE TERMINAL ANNEX POST OFFICE IS LESS THAN TWO BLOCKS FROM THE PLACE WHERE KENNEDY WAS STRUCK.
