New York, Aug. 20 (AP)- Jack Ruby, in a rbamling, almost incoherent appeal to the Warren commission, has insisted he never took part in any plot to assassinate President John F. Kennedy, or to kill Lee Harvey swald.

There was no conspiracy," Ruby is quoted in today's New York Journal-American.

In reply, Chief Justice Earl Warren told Ruby:

"I think I can say to you that there has been no witness before this commission out of the hundreds we have questioed who has claimed to have any personal knowledge that you were a zz party to any conspiracy to kill our President.

"I just wanted to tell you before our own commission, and I might say to you also that we have explored the situation."

The exchange is a highlinght of a final copyrighted installment in the Journal-American of a 102 page *** interro ation of Ruby in the Dallas County Jail June 7 by the Warren commission.

The transcript has been published in three installments, under the byline of Journal-American columnist Dorothy Kilgallen. She said she obtained a copy "through sources close to the commission in Washington."

Ruby shot Oswald in Dallas police headquarters Nov. 24 during a routine jail transfer. Oswald, a self-described Marxist, had been formally accused of the Nov. 22 assassination of President Kennedy.

Condemned to death last March 14 by a Dallas trial jury, Ruby is held in the Dallas County jail pending appeal of his conviction. The did not take the witness stand at his trial. However, in previous installments, he told the Warren commission he killed Oswald on the sput of the moment, to spare Mrs. John F. Kennedy the ordeal of returning to Dallas for Oswald's trial.

At the outset of the final installment, Ruby is quoted as saying:

"....There is a certain organization in this area that has been indoctrinated, that I am the one that was in the plot to assassinate our President."

"Would you tell us what this is," he was asked.

The John Birch Society," Ruby replied, referring to the internal ultra-conservative organization opposed to what it regards as international subversion in this country by communism.

*Ruby was then questioned about an unsubstantiated rumor of a secret meeting in his Dallas strip joint shortly before the Kennedy assassination.

After much give and take on the subject, Ruby is quoted in reply:

"No. I am as innocent regarding any conspiracy as any of you gentlemen in the room..."

Ruby repeatedly expressed the nonviction that he was being made the scapegoat in the Kennedy assassination because he is Jewish and that his own live and those of his brothers and sisters were in danger. He is quoted:

"Well, assuming that, as I stated before, some persons are accusing me falsely of being part of the plot -- natrually, in all the time from over six months ago, my family has been so interested in helping me."

"By that, you mean a party to the plot of "swald ?" he was asked.

"That I was party to a plot to silence Oswald," Ruby continued.

"....My brother, who had a successful business, I know he is going to be killed....when I told him I did it because of Mrs. Kennedy, that is all he had to hear, because I would never involved him in a conspiracy....

******* The people that have power here, they have a different verdict. They already have me as the accused assassin of our beloved President...."

At that point, Warren offered his assurance that the commission had no evidence of such a phot, and added that if such testimony hid come to light, Ruby would be given an opportunity to answer it.

"I don't anticipate that there will be any sucy testimony," Warren went on, "but should there be, we will give you the opportunity. Does that seem fair?"

"No," Ruby's reply reads. "That isn't going to save my family....through certain falsehoods that have been said about me to other people, the John Birch Society, I am as good as guilty as the accused assassin of President Kennedy. How can you remedy that, Mr. Warren?

"...unfortunately, Chief Earl Warren, had you been around five or six months ago....and imme iately the President would have gotten a hold of my true story, or whatever would have been said about ie, a certain organization wouldn't have some completely formed me, so powerfully, to use me because I am of the Jewish extraction, **x*** Lewish faith, to commit the most dastardly crime that has ever been committee....

"I want to say this to you. The Jewish people are being exterminated at this moment. Onsequently, a whole new form of government is going to tak over our country, and I know I won't live to see you another time.....

"I am used as a scapegoat, and there is no greater weapon that you can use to create some falshood about some of the Jewish faith, expecially the terrible heinous crime such as the killing of President Kennedy.

"Now maybe something can be saved. It may not be too late, whatever happens, if our President Lyndon Johnson knew the truth about me. But if I am eliminated xx xx xx xx xx xx xx there won't be any way of knowing...

"But he has been told, I am cerain, that I was part of a plot to assassinate the President. I know your hands are tied, you are helpless."

"Mr. Ruby," Warren said, "I think I can say this you you, that if he has been told any such thing, there is no indication of any kind that he believes it."

At another point, Ruby is quoted as saying:

"You have lost me though. You have lost me, Chief Justice Warren."
"Lost you in what sense?" Warren asked. Ruby replied:

"I won't be around for you to come and question me again...you have a lost cause, Earl Warren. You don't stand a chance. They feel about you like the

do about me, Chief Justice Warren...and all I want to do is tell the truth, and that is all.

"There was no conspiracy."
