DALLAS, AUG. 25 (AP)-DEFENSE LAWYERS HAVE ADDED DOCUMENTS TO THE OFFICIAL RECORDS OF THE JACK RUBY MURDER TRIAL TO BACK THEIR CLAIM A KEY PROSECUTION WITNESS GAVE FALSE TESTIMONY.

THE DOCUMENTS WERE AFFIDAVITS SIGNED BY DALLAS AND FORT WORTH TELEVISION NEWSMEN AND LAWYERS. THEY SUPPORTED DEFENSE CLAIMS THAT POLICE SGT. PATRICK DEAN DID NOT TELL THE TRUTH ABOUT HIS CONVERSATION WITH RUBY AFTER THE SHOOTING OF LEE HARVEY OSWALD, ACCUSED ASSASSIN OF PRESIDENT KENNEDY.

IN BILLS OF EXCEPTION FILED WITH DIST. JUDGE JOE BROWN LAST MONTH, DEFENSE LAWYERS SAID DEAN TESTIFIED HE TALKED WITH RUBY IN THE CITY JAIL ABOUT 10 MINUTES AFTER THE FORMER NIGHT CLUB OPERATOR GUNNED DOWN OSWALD.

AT THE TRIAL DEAN TESTIFIED RUBY SAID HE THOUGHT OF KILLING OSWALD TWO DAYS BEFORE THE NOV. 24 SLAYING.

AFFIDAVITS SUBMITTED YESTERDAY SAID FILMS OF TELECASTS BY KRLD-TV IN DALLAS AND WBAP-TV IN FORT WORTH SHOW DEAN IN THE BASEMENT OF THE CITY HALL FOR 21 MINUTES AND 33 SECONDS AFTER THE SHOOTING OF OSWALD.

THE THREE AFFIDAVITS ABOUT DEAN'S PRESENCE IN THE BASEMENT AS SHOWN IN THE FILMS WERE SIGNED BY KRLD-TV EMPLOYES DAN GARZA, RICHARD H. WHEELER AND LESLIE SEURES.

TWO OTHER AFFIDAVITS, SIGNED BY KRLD-TV NEWSMAN WES WISE AND DOYLE VINSON OF WBAP, SAID DEFENSE LAWYERS ASKED TO VIEW THE FILMS FOR TIMING ON APRIL 28.

FILING OF THE DOCUMENTS REPRESENTS THE FINAL LOCAL STEP IN THE APPEAL OF A DEATH PENALTY VERDICT RETURNED MARCH 14.

WHEN COURT REPORTERS FINISH TRANSCRIBING THE LÊNGTHY OFFICIAL TRIAL RECORD THE PAPERS WILL BE SENT TO THE COURT OF CRIMINAL APPEALS IN AUSTIN.
