Ruby was taken to the same hospital where President John F. ennedy died after he was shot by a rigleman on Nov. 22, 1963.

Two days later, before a national television audience, Ruby shot Oswald fatally as the accused assassin was being transferred from the city jail to the country jail.

There was a report that Ruby was suffering from pneumonia, but Dr. J.M. Pickert was quoted by television station KRLD as saying Ruby had a "severe cold." Pickert is the Dallas County health officer.

Rub was convicted and given a death sentence for the slaying of Oswald, but only recently the Texas Court of Criminal Appeals reversed the conviction and ordered a new trial for the former strip-tease joint operator.

She rushed upstairs to the floor where Ruby was hospitalized and called Thil Burleson, one of the Ruby defense lawyers.

"I just saw him Tuesday," Earl Ruby continued, "and he looked terrible.

Asked if Jack had also complained to jail officials, Earl answered, "Yes, they knew about it. There were treating him for a cold."

Earl Ruby said he was expecting a call from Parkland and would decide then whether to go to Dallas.

"I may leave tomorrow morning," he said, "but I'LL just have to wait and see." He said he would go to Dallas alone.

Dallas, Tex. Dec. 9 (AP)- Jack Ruby, the stubby strip joint boss who killed Lee H rvey Oswald, was taken to Parkland Hospital late today with an illness described as a serious case of pneumonia.

Ruby, 55, had been under treatment in his jail cell for a work bad cold for about three weeks.

Sheriff Bill Decker said he was admitted to the hospital about 5:15 p.m. following a ratine examination by Dr. John. R. Callahan, assistant county health officer.

Excent for defense claims that he was mentally sick, it was Ruby's first reported illness since he gunne down Oswald, later named by the Warren Commission as assassin of President John F. Kennedy, on Nov. 24, 1963, two days after the assassination.

After he was convicted of murder in February, 1964, and given the death sentence for killing Oswald, Ruby's attorneys said he had attempted suicide -- once by banging his head against a wall and once by sticking his finger in a light socket.

District Attorney Henry Wade said the defense claims were a play for sympathy.

The Texas Court of Friminal Appeals ordered a new trial for Ruby recently, and last week Judge Louis Holland set the second trial for Wichita Falls, probably in FFebruary.

In court appearances after the assassination and ruing his murder trial, Ruby's usually ruddy complxion was waxy and he had lost weight. But in court since then he seemed to have regained his plump figure.

Pa bland, the city-county hospital where both President Kennedy and Oswald died, issued this statement:

"Jack R by was admitted to Parkland Hospital at 5:15 this afternoon. His condition was listed as serious. The admitting diagnosis was pneumonia.

"The next statement on his condition will be at 9 a.m. (GST) tomorrow."

Decker said 'e delivered Ruby to the hospital at 4:57 .m. "Security will be maximum," he said.

Rub was taken to a rrivate room and hospital authorities said me only visitors approved by Decker would be permitted to see him.

There was no evidence of excitement at the hospital. No police cars were in sight and the lobby was deserted except for newsmen.

Mrs. Eva Grant, Ruby's sister, arrived at the hospital soon after her brother.

She went to his upper floor room after telling reporters he had been ill for three weeks and had no been property treated.

Decker said, "I understand he's had a cold for several weeks."

But he said Rub had not been exposed while in jail and added "this all came about because of a routine examination" by Dr. Callahan.

Dollas, Tex., Dec. 9 (AP)- Jack Ruby, the stubby stip joint boss who killed Lee Harvey Oswald, was taken to Parkland Hospital late tday with an illness described as a serious case of pneumonia.

"That guy's dying," said Ruby's sister, Mrs. Eva Grant.

The jail doctor said Ruby had a "throat-tickling king of cough" -- and no fever.

The hospital said the admission diagnosis was rneumonia and listed Ruby's condition as serious.

Except for defense claims that he was mentally sick, it was Ruly's first reported illness since he gunned down Oswald, later named by the Warren Co mission as the assassin of President Kennedy.

Sheriff Bill Decker said he ordered Ruby transferred to the hospital on the advice of Dr. J.M. Pickard, county health officer, after routinely visiting Ruby's cell for the first time in 10 days.

Dr. John W. C llahan, Pickard's assistant, said he had been seeing Ruby daily for two weeks because of a cold.

"I examined him at 10 a.m. today," he said, "and his cold seemed to be subsiding. I thought he was improving. I was surprised to hear tonight that he had gone to the hospital."

Callahan said "the sheriff can act any time he wants in a case like this."

Mrs. Grant visited Ruby in his hosmital room and then told a reporter: "I'm not leaving. I'll be here all night. I don't even trust the hospital . . . that guy's dying."

She said she saw Ruby earlier today and he looked "terrible, like a corpse . . . for three weeks, he's been deathly sick."

Decker said he decided to drop in on Ruby today and: "Jack said he had a bad cold and wasn't feeling up to par. I talked to Dr. Pickard and he suggested Jack should be taken to the hospital where he couldbe x-rayed, examined and tests made."

Callahan, who has been practicing medicine for 15 years, said he had been giving Ruby cough med cine and, for the past three days, antibiotics.

Ruby gunned down Oswald in the basement of the Dallas city jail on Nov. 24, 1963, two days after President Kennedy was assassinated.
