NEW YORK, OCT. 29 (AP) - EPISCOPAL BISHOP JAMES A. PIKE AND EDWARD M. KEATING, PUBLISHER OF RAMPARTS MAGAZINE, SAID TODAY THEY ARE FORMING A COMMITTEE TO ASK PRESIDENT JOHNSON TO RELEASE WHAT THEY CALLED "SUPPRESSED" EVIDENCE BEARING ON PRESIDENT JOHN F. KENNEDY'S ASSASSINATION.

PIKE DISCUSSED THE COMMITTEE WITH NEWSMEN ON HIS ARRIVAL FROM THE WHEELING, W. VA., MEETING OF THE EPISCOPAL HOUSE OF BISHOPS WHICH ACCEPTED A COMMITTEE RECOMMENDATION THAT HERESY CHARGES AGAINST HIM NOT BE STARTED, BUT CENSURED PIKE FOR "IRRESPONSIBILITY" IN SOME STATEMENTS ESPOUSING LIBERAL THEOLOGY.

PIKE SAID HE CAME TO THE CONCLUSION THAT KENNEDY WAS THE VICTIM OF A CONSPIRACY, NOT A LONE ASSASSIN. THE BISHOP SAID HIS THINKING ON THE CONPSIRACY POSSIBLY DATED BACK A YEAR.

.KEATING JOINED WITH THE BISHOP AT KENNEDY AIRPORT TO DISCUSS THE COMMITTEE. PIKE STOPPED OFF THERE ENROUTE TO A CHURCH MEETING IN CLEVELAND.

BOTH MEN SAID THEY WOULD ACCEPT THE LONE-ASSASSIN THEORY IF IT WERE CONFIRMED BY EXAMINATION OF THE "SUPPRESSED" EVIDENCE.

KEATING CHARGED THAT ABOUT 90 PER CENT OF THE DATA FROM THE CENTRAL INTELLIGENCE AGENCY AND ABOUT 50 PER CENT OF THE FBI'S EVIDENCE WAS WITHHELD.

THE WARREN COMMISSION, IN THE FOREWORD TO ITS REPORT, SAID IT GOT FULL COOPERATION FROM ALL AGENCIES, INCLUDING THE CIA AND FBI, AND THAT IT WAS "COMMITTING ALL OF ITS REPORTS AND WORKING PAPERS TO THE NATIONAL ARCHIVES, WHERE THEY CAN BE PERMANENTLY PRESERVED UNDER THE RULES AND REGULATIONS OF THE NATIONAL ARCHIVES AND APPLICABLE FEDERAL LAW."

THE COMMISSION FOUND NO EVIDENCE, IT SAID, THAT ANYONE ASSISTED THE ACCUSED LEE HARVEY OSWALD IN PLANNING OR CARRYING OUT THE ASSASSINATION. IT SAID THAT NEITHER OSWALD NOR JACK RUBY, CONVICTED OF KILLING OSWALD, WAS PART OF ANY CONSPIRACY, DOMESTIC OR FOREIGN.
