NIGHT LEAD MRS. OSWALD

WASHINGTON, FEB.12 (AP)-MRS. MARGUERITE OSWALD SAID TODAY SHE
TOLD THE WARREN COMMISSION SHE BELIEVES HER SON WAS A U.S.
INTELLIGENCE AGENT WHO WAS "SET UP TO TAKE THE BLAME" FOR PRESIDENT
JOHN F. KENNEDY'S ASSASSINATION. SHE SAID SHE BELIEVES HER SON WAS
INNOCENT.

THE 56-YEAR-OLD MOTHER OF LEE HARVEY OSWALD FINISHED THREE DAYS OF TESTIMONY TO THE PRESIDENTIAL INVESTIGATING COMMISSION. THEN SHE HELD AN IMPROMPTU NEWS CONFERENCE IN WHICH SHE ACKNOWLEDGED--DESPITE HER BELIEF IN HIS INNOCENCE--THAT:

"I REALIZE THAT AS A HUMAN BEING HE COULD BE GUILTY."

BUT SHE SAID SHE POSSESSES "PERTINENT EVIDENCE" LEADING HER
TO BELIEVE THE ASSASSIN IS STILL AT LARGE.

CHIEF JUSTICE EARL WARREN TOLD NEWSMEN AFTER THE HEARING, HOWEVER, THAT THE FORT WORTH PRACTICAL NURSE OFFERED NO EVIDENCE TO SUPPORT HER BELIEF THAT THE 24-YEAR-OLD EX-MARINE WAS A SECRET AGENT FOR THE VENTRAL INTELLIGENCE AGENCY.

WARREN SAID MRS. OSWALD'S LENGTHY TESTIMONY PROVIDED' NO FACTS
HAT WOULD "CHANGE THE PICTURE AS WE KNEW IT UP TO THE TIME SHE
TESTIFIED."

THE BULK OF EVIDENCE IN THE COMMISSION'S HANDS--INCLUDING A
FIVE-VOLUME FOR REPORT--POINTS TO OSWALD, WHO BECAME INTERESTED IN
MARKISM AS A TEENAGER, AS THE LONE PERPETRATOR OF THE
ASSASSINATION IN DALLAS NOV.22.

WARREN SAID HE BELIEVED SOME OF THE MOTHER'S TESTIMONY WOULD BE USEFUL, HOWEVER, AND SUMMED UP HER PRESENTATION WITH THIS SENTENCE:

"SHE SAYS SHE BELIEVES HER SON IS INNOCENT, THAT IT IS POSSIBLE THAT HE COMMITTED THE CRIME, BUT THAT IT IS POSSIBLE THAT OTHER

PEOPLE COULD HAVE COMMITTED IT."

THE PLUMP, MOTHERLY LOOKING WOMAN WENT READILY TO A GROUP OF MICROPHONES, WHEN THE HEARING ENDED AND IMMEDIATELY BEGAN TO TELL HER STORY IN WORDS THAT GAINED INTENSITY AND RAPIDITY AS SHE WENT ALONG.

SHE SAID SHE INTENDS TO CONTINUE "MAKING PUBLIC APPEARANCES AND INVESTIGATIONS, IF IT TAKES ANOTHER YEAR," TO FIND THE ASSASSIN.

SHE WILL WORK, SHE SAID, WITH MARK LANE, A NEW YORK LAWYER WHO IS CURRENTLY MAKING SPEECHES AND LECTURES IN OSWALD'S BEHALF ACROSS
HE COUNTRY.

THE MOTHER SAID SHE AND LANE HAVE "COME ACROSS A FEW

DISCREPANCIES" IN STATEMENTS THUS FAR MADE ON HER SON'S ARREST.

IMMEDIATELY AFTER THE FATAL SHOTS WERE FIRED FROM THE DALLAS BUILDING WHERE HE WORKED.

WHEN ASKED WHETHER THIS MEANT SHE FELT THE COMMISSION WAS NOT PERFORMING A COMPLETE JOB, MRS. OSWALD HASTILY PROTESTED:

"OH, NO. THAT I DID NOT MEAN TO IMPLY. I HOPE TO RELP THE COMMISSION FIND THE ASSASSIN BECAUSE I BELIEVE MY SON WAS A SCRAPGOAT (SIC) IN THIS."

REPORTERS ASSUMED SHE MEANT SCAPEGOAT, AND ASKED THE BASIS FOR HER DELIEF. SHE REPLIED THAT THIS WAS INDICATED BY THE FACT, AS SHE PUT IT, THAT DALLAS POLICE AND SECRET SERVICE AGENTS "CLOSED THE CASE IN 12 HOURS."

"I DON'T BELIEVE THAT IN A PERIOD OF 12 HOURS' TIME, AND WHEN THEY DIDN'T CATCH HIM AT THE TIME (OF THE ASSASSINATION), THAT YOU CAN SAY THAT HE ALONE WAS GUILTY."

WHEN IT WAS SUGGESTED THAT THIS CLASHED WITH THE BELLEF OF OSWALD'S YOUNG RUSSIAN-BORN WIFE, MARINA, WHO TESTIFIED FOR FOUR DAYS LAST WEEK, THE OLDER MRS. OSWALD REPLIED THAT HER DAUGHTER-IN-

AW "HAS THE PRIVILEGE OF SAYING ANYTHING SHE WANTS TO SAY AND I RESPECT THAT PRIVILEGE," BUT THAT SHE, THE MOTHER, HAD THE SAME PRIVILEGE. SHE RESPONDED EAGERLY WHEN A REPORTER ASKED WHETHER, AS HAS BEEN REPORTED, SHE BELIEVED THAT OSWALD--WHO WENT TO RUSSIA IN 1959 AFTER

EAVING THE MARINES AND LIVED THERE UNTIL 1962--WAS A U.S. INTELLIGENCE AGENT.

"YES, I BELIEVE LEE WAS AN INTELLIGENCE AGENT, AND I SO STATED O THE WARREN COMMISSION," SHE SAID.

ASKED IF SHE HAD PROOF, SHE REPLIED:

"IF I COULD PROVE IT I WOULD SAY SO, BUT WHO CAN SEE LEE WAS A

"DEING AN AGENT, HE WOULD NOT SAY IT TO ANYONE."

WARREN SAID THE COMMISSION HAS RECEIVED. NO EVIDENCE FROM ANY
FEDERAL ACENCY TO SUBSTANTIATE THE VIEW THAT OSWALD EVER WORKED FOR
ANY GOVERNMENT AGENCY.
