Washington, March 24 (AP)- A man who said he saw the person who fired the shots shen President John F. Kennedy was assassinated testifiteday before the commission investigating Kennedy's death.n

Four other men wb were in or around the building from which police said the shots were fired also appeared before the commission. All are from Dallas, where Kennedy was shot to death last Nov. 22.

At the noon recess. Allen Dulles, a commission member, told reporters it had been "interesting testimony as to persons who were there -- in the building at the time or outside -- who saw the shots fired."

Asked if they also saw the person who fired the shots, Dulles replied, "In one case."

Enough to identify the person ?

"I don't think I8d better go any further, "Dulles replied.

Others were who were close to the tragic event that day are to appear as witnesses tomorrow.

The commission said tomrrow's witnesses, all from the Dallas area, will be Patrolman Marion Baker and Mrs. R.A. Reid, who were near the building when the shots were fired; deputies Eugene L. Boone and Luke Mooney, who took part in the shooting investigation; and Patrolman M.N. NMcDonald, who helped arrest Lee Harvey Oswald in a theater later.

The commission's 26 26th witness was the man who has said previously he saw the shots fired.

"I saw him. The gun-was sticking out the window. I saw him fire a second time. He didn't seem to be in no hurry." -- these were the words of H.L. Brennan about that moment in history last November when Kennedy was assassinated in Dallas.

Brennan, a steamfitter, was on the street below the sixth floor window of the texas school book depository building from which police say Lee Harvey swald fired the fatal shots. Oswald was slain two days later.

Other witness on today's list are employes of the building -building superintendent Roy S. Truly and James Earl Jarman, Bomnie Ray williams and Harold Norman.

According to accounts of the assassination aftermath, policeman rushed into the warehouse and with Truly began a search. The policeman noticed Oswald and asked if he belonged in there, and Truly replied that Oswald worked there.

As previous reports go, Oswald dashed to the opposite corner of the building after the shooting, tossed the rifle behind a stack of boxed books, then ran down a rear staircase. He slipped out of the building and into the crowd.

Oswald, 24, was a stock clerk at the book warehouse. He had taken the job Oct. 15, just five weeks before Kennedy was killed.

Mamantov served as translator during the Dallas police interrogation of Marina Oswald, km widow of the man charge with Kennedy's death, Lee Harvey swald. He was shot and killed Nov. 24 during a jail transfer.

Five attorneys are now investigating in Dallas and two more are expected.

Others who were interviewed yesterday included deputy police Chief M.w. Stevenson and the two Parkland Hospital physicians who zauxezz announced Oswald's death, Dr. Charles Gregory and Dr. Tom Shires.

So far, the attorneys have taken statements from 13 persons, getting a step by step account of events here last November.
