TOMORROW THE COMMISSION GATHERING FACTS ABOUT THE ASSASSINATION HAS CALLED IN FIREARMS AND BALLISTICS EXPERTS.

THE TWO DOCTORS WERE AT PARKLAND HOSPITAL IN DALLAS WHERE KENNEDY WAS RUSHED AFTER A SNIPER'S BULLETS WOUNDED HIM FATALLY.

THEY WERE DR. CHARLES J. CARRICO, 28, AND DR. MALCOLM O. PERRY,

REPORTS OF THE SEVEN DOCTORS WHO ATTENDED KENNEDY AT THE HOSPITAL ALREADY HAVE BEEN PUBLISHED IN THE TEXAS STATE JOURNAL OF MEDICINE.

THEY SAID KENNEDY HAD A FAINT HEART BEAT WHEN HE WAS BROUGHT TO THE EMERGENCY ROOM BUT HIS WOUNDS WERE TOO GREAT FOR SURVIVAL.
