DALLAS, JUNE 28 (AP)-PUBLICATION OF A DIARY WRITTEN BY LEE HARVEY OSWALD BROUGHT A DEMAND FOR AN INVESTIGATION TODAY FROM THE ATTORNEY OF THE ACCUSED ASSASSIN'S WIDOW.

THE LAWYER, WILLIAM A. MCKENZIE, SAID, "MARINA OSWALD FEELS THAT ALL EVIDENCE SHOULD BE GIVEN TO THE WARREN COMMISSION AND ONLY RELEASED BY THE COMMISSION."

THE COMMISSION IS SCHEDULED TO REPORT TUESDAY ON ITS INVESTIGATION OF THE SLAYING OF PRESIDENT JOHN F. KENNEDY LAST NOV. 22 IN DALLAS. POLICE SAY OSWALD FIRED THE SHOTS.

REP. GERALD R. FORD, R-MICH., A MEMBER OF THE WARREN COMMISSION, SAID IN WASHINGTON HE WAS DISTURBED BY PUBLICATION OF THE DIARY EXCERPTS AND THAT THE MATTER UNDOUBTEDLY WOULD BE DISCUSSED BY THE COMMISSION AT ITS MONDAY MEETING.

PORTIONS OF THE DIARY AND OTHER WRITINGS WERE PUBLISHED IN COPYRIGHT STORIES DURING THE WEEKEND BY THE DALLAS MORNING NEWS.

MCKENZIE, IN A FORMAL NEWS STATEMENT SAYING HE SPOKE FOR MRS. OSWALD, SAID THE SOURCE OF THE OSWALD INFORMATION POSSIBLY WAS A PUBLIC OFFICIAL.

HE SAID MRS. OSWALD TURNED OVER ALL SUCH MATERIAL TO GOVERNMENT AGENCIES AND DOES NOT HAVE COPIES OF IT.

THE LAWYER SAID HE REQUESTED THAT THE CHIEF COUNSEL FOR THE WARREN COMMISSION, J. LEE RANKIN, INVESTIGATE.

MCKENZIE SAID RANKIN TOLD HIM BY TELEPHONE THAT THE COMMISSION DID NOT RELEASE THE DIARY.

RANKIN, REACHED IN NEW YORK, SAID, "WE JUST DON'T DO THOSE THINGS (COMMENT)" WHEN ASKED ABOUT MCKENZIE'S STATEMENT.

QUESTIONED, "WERE YOU ASKED TO INVESTIGATE?" RANKIN REPLIED, "WE DON'T TELL WHAT THE COMMISSION DOES."

MCKENZIE SAID COPIES OF THE DIARY WERE IN THE POSSESSION OF THE DALLAS POLICE DEPARTMENT, THE FBI, SECRET SERVICE, DALLAS DISTRICT ATTORNEY'S OFFICE, THE U.S. ATTORNEY GENERAL'S DEPARTMENT AND THE WARREN COMMISSION.

"I FEEL THAT SOMEONE, AFTER THE DIARY WAS IN OFFICIAL HANDS, PHOTOSTATED THE DIARY FOR HIS OR HER OWN SELFISH PURPOSES," MCKENZIE SAID.

JACK RUBY, 53, STRIPTease CLUB OPERATOR, SHOT THE 24-YEAR-OLD OSWALD TO DEATH NOV. 24 IN THE BASEMENT OF THE DALLAS CITY HALL DURING A ROUTINE JAIL TRANSFER. RUBY WAS SENTENCED TO DEATH AND THE CASE IS ON APPEAL.

THE OSWALD DIARY AND OTHER WRITINGS DETAIL HOW HE REACHED MOSCOW OCT. 16, 1959, AND APPLIED FOR SOVIET CITIZENSHIP, SAYING "HIS FONDEST DREAMS" CENTERED ON RESIDING IN RUSSIA.

HE SLASHED HIS WRIST WHEN POLICE TOLD HIM TO GET OUT OF THE COUNTRY, BUT HIS LIFE WAS SAVED BY AN INTOURIST GUIDE WHO FOUND HIM IN TIME, THE DIARY RELATES.

THE RUSSIANS THEN PERMITTED HIM TO REMAIN, FOUND HIM A JOB AND MUCH LATER ASKED HIM IF HE WISHED CITIZENSHIP.

OSWALD BY THAT TIME WAS SO DISILLUSIONED THAT HE DECLINED CITIZENSHIP, ONLY ASKING THAT HIS RESIDENCE PERMIT BE EXTENDED.

HE BECAME SO BITTER ABOUT THE COMMUNISM HE ONCE EMBRACED THAT HE CALLED ITS LEADERS "SICK."

AT ONE POINT IN THE DIARY HE CALLED HIMSELF A COMMUNIST. BUT WHEN ARRESTED AFTER THE ASSASSINATION HE DECLARED INSTEAD THAT HE WAS A "MARXIST"--A FOLLOWER OF KARL MARX, THE THEORIST WHOSE WRITINGS BECAME THE BASIS OF COMMUNISM.

THE DREAD RUSSIAN SECRET POLICE PAID HIM 700 RUBLES A MONTH, THUS DOUBLING HIS FACTORY PAY, UNTIL IT DISCOVERED ABOUT TWO YEARS AFTER HIS ARRIVAL THAT HE SOUGHT TO RETURN TO THE UNITED STATES.

THE SECRET SERVICE MONEY, OSWALD WROTE, WAS DISGUISED AS A RUSSIAN RED CROSS CONTRIBUTION.

OSWALD BOASTED OF SEVERAL LOVE AFFAIRS AFTER HE WAS ASSIGNED A JOB IN MINSK, 468 MILES SOUTHWEST OF MOSCOW. HE SAID HE MARRIED MARINA TO HURT ANOTHER WOMAN WHO SPURNED HIM, BUT THEN FELL IN LOVE WITH MARINA, A PHARMACIST.

MUCH OF HIS WRITINGS AFTER HE LEFT RUSSIA TELL OF DISILLUSIONMENT WITH COMMUNISM. HE SAID, FOR INSTANCE, THAT TELEVISION-RADIO-PHONOGRAPH SETS SHOWN AT INTERNATIONAL TRADE FAIRS ARE SPECIALLY MADE BUT CALLED ASSEMBLY LINE PRODUCTS. HE SAID FARMERS LIVE IN ABJECT POVERTY EXCEPT ON SHOWPLACE COLLECTIVE FARMS, AND THAT CORRUPTION AND

EMBEZZLEMENT ARE WIDESPREAD.

OSWALD CALLED THE PEOPLE HE MET GOODHEARTED, KIND, ROUGH AND TOUGH.
BUT HE REPEATEDLY USED THE WORD "UNTRUSTWORTHY" TO DESCRIBE THEM.

The Dallas News story was accompanied by a front page picture of Oswald's vaccination certificate, required for a U.S. passport. It was dated June 8, 1963, and shows the stamp of Dr. A.J. Hideel.

No such Dr. Hideel is listed in the New Orleans, La., telephone directory.

Oswald used the name of A.J. Hidell in purchasing the rifle which police said was used in the assassination of President John F. Kennedy.

The signature on the vaccination certificate appears to be Oswald's, the newspaper said.
