JOHN J. MCCLOY

BANKER, SCHOLAR AND DIPLOMAT, AT 69 LOOKS BACK ON ALMOST A QUARTER-CENTURY PUBLIC SERVICE UNDER DEMOCRATIC AND REPUBLICAN PRESIDENTS; REMEMBERED BEST PERHAPS AS POST-WAR HIGH COMMISSIONER FOR GERMANY.

ALLEN W. DULLES

AT 71 A RETIRED SPYMASTER PRACTICING LAW; RAN AN ESPIONAGE APPARATUS IN ITALY AND GERMANY DURING WORLD WAR II, LATER DIRECTED THE CENTRAL INTELLIGENCE AGENCY.

GERALD R. FORD

AT 51, COMPLETING HIS SEVENTH TERM AS A REPUBLICAN CONGRESSMAN FROM MICHIGAN; IS CHAIRMAN OF THE HOUSE REPUBLICAN CAUCUS.

HALE BOGGS

AT 50 IS THE NO. 3 MAN IN THE HOUSE HIERARCHY, THE DEMOCRATIC WHIP; ROUNDING OUT HIS 24TH YEAR AS A LOUISIANA CONGRESSMAN.

JOHN SHERMAN COOPER

KENTUCKY-BORN, IVY EDUCATED, AT 63 SERVING HIS FIRST FULL TERM AS A KENTUCKY SENATOR, FILLED OUT OTHERS' TERMS ON TWO PREVIOUS OCCASIONS; A LIBERAL REPUBLICAN AND FORMER AMBASSADOR TO INDIA AND NEPAL.

RICHARD B. RUSSELL

CONSERVATIVE GEORGIA DEMOCRAT, AT 66 A SENATE POWER AS CHAIRMAN OF THE ARMED SERVICES COMMITTEE AND RECOGNIZED LEADER OF SOUTHERN DEMOCRATS, PARTICULARLY IN COMBATTING CIVIL RIGHTS LEGISLATION. JF5 ACS
