Jack Ruby: 'I was framed to kill Oswald!'

Ed. Note: This article, the second in a two-part series, was compiled by Don Freed, Jim Cookson and Jeff Cohen of the campaign for Democratic Freedoms.

In August 1974, the London Sunday Times disclosed that Jack Ruby admitted to his psychiatrist that he was part of a conspiracy to frame Lee Harvey Oswald.

James Earl Ray's attorneys presented evidence at an October 1974 hearing that their client, who has always maintained his innocence, was forced into a guilty plea. Ray recently identified a CIA/mob hitman as being at the scene of the King murder. The hitman was also linked to Ruby in the Warren Commission volumes.

A New York Times interview with ex-FBI agent Arthur Murtagh revealed that the bureau's surveillance of Dr. King was "massive and complete." Missing from the Times was Murtagh's comments that he saw conspiracy "leads being washed out" in both the JFK and King murder investigations.

According to Zodiac News Service, Murtagh's reports on Jack Ruby's ties to right-wing Cubans were submitted — and then doctored. The ex-FBI man believes that right-wing conspiracies were behind both murders.

Zodiac also released a story on Sirhan Sirhan's cellmate, who was found stabbed to death shortly after writing to a Nevada State Assemblyman that Sirhan had disclosed that more than one gun was employed in the RFK assassination.

The January 1975 issue of Harper's magazine contained an article (edited by Alexander Cockburn) which explored the forensic scientific evidence that supports the conclusion of two guns in the Ambassador Hotel pantry that June night in 1968. Ex-Congressman Allard

Lowenstein has called for a new investigation.

After years of petitioning, researcher Harold Weisberg

obtained and published the transcript of the executive session in which Warren Commission members discuss methods of exploring/ignoring the evidence that Oswald was an FBI informant. The Commission operated in fear of J. Edgar Hoover, and in fear of the truth.

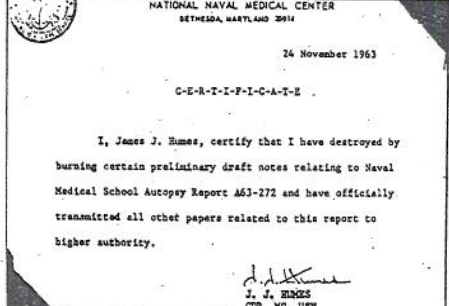
Gerald Ford, the ex-Warren Commissioner, illegally published much of this classified document in his book, *Portrait of the Assassin*. Ford committed perjury when he denied the charge at his vice-presidential confirmation hearings.

The Assassination Information Bureau conference Feb. 1, 1975 in Boston brought researchers together to map strategy for a political move-

ment that would force the issue of political murder before Congress and the American people.

On the eve of the conference, Congressman Henry Gonzalez, D-Tex., introduced a bill that would establish select committees to investigate the decade of gunplay. Researchers and activists accelerated the pace of lec-



tures, Zapruder film showings, teach-ins and congressional ear-banding.

Now, for the first time in 11 and a half years, a segment of the mass media is exploring the assassination issue as political murder instead of unrelated flukes of history.

The much publicized *Penthouse* excerpt from a new book, *The Assassination Tapes*, penned by George O'Toole, ex-CIA Chief of Problem Analysis, has brought "termination" of his government security clearance and a hysterical attack (on official stationery) from the Rockefeller/CIA panel.

O'Toole's reply will appear in the press in a few weeks. He plans to sue his ex-employer for his life.

The April 3 issue of *The New York Review of Books* presents

photographs taken by the CIA of a man posing as Lee Oswald at the Russian Embassy in Mexico City on Oct. 1, 1963. And a devastating probe into the soft underbelly of "the company's" (CIA's) cover story by O'Toole and Bernard Fensterwald.

A recent New York Times article reveals a memo from Hoover to the State Department in 1960 indicating that an imposter was using Oswald's credentials. The memo, an early warning of Oswald's intelligence activities, was not shown to the Warren Commission staff.

A *Rolling Stone* piece reports that an ex-commission staffer, Judge Burt Griffin, has called for an official reopening of the JFK case. David Belin, chief counsel for Rockefeller's CIA panel, is exposed by *Stone* as a Warren Commission attorney who altered testimony when it did not fit.

After 11 years, the Zapruder film is finally shown, to un-

precedented public response, on a network TV show, ABC's *Good Night America*. This single most important piece of evidence in the case was bought and suppressed by *Time, Inc.* in 1963.

The obligatory graphic appears, at last, on the cover of a national weekly, *New Times* (April 18, 1975): a painting of Kennedy's head exploding from a right, front shot. In the wake of article after article, Walter Cronkite begins to shift on the CIA and foreign assassinations. The CBS *60 Minutes* team starts a secret new investigation into the real lives of Lee Harvey Oswald and Jack Ruby.

Cronkite releases the suppressed "National Security" portion of his 1969 interview with Lyndon Johnson. The president who appointed and defended the Warren Commission and its lone-nut conclusion points to an "international"

Kennedy assassination documents released

Assassination researcher Harold Weisberg has forced the U.S. government to release a series of documents concerning the assassination of President John F. Kennedy that lends additional weight to the argument that the Warren Commission investigation was a sham and coverup.

Weisberg, who has authored five books on the Kennedy assassination, obtained FBI chemical tests which, he says, prove that Lee Harvey Oswald could not possibly have been a lone assassin and a government document indicating that President Ford, who was a member of the Warren Commission, suspected that Lee Harvey Oswald was in fact an undercover FBI agent.

Freedom of Information

The transcript obtained by lawsuit through the recently revised Freedom of Information Act (which was enacted into law over Ford's veto) details a Jan. 22 meeting in which Ford and other Warren Commission members discussed the distinct possibility that Oswald was held several meetings with the FBI in the past year in an effort to uncover evidence which might prove that Arthur Bremer was a hired assassin. The *Times* says, however, that the FBI continues to tell Wallace it has discovered no evidence of a conspiracy involving Bremer.

In a *Times* interview Wallace says he continues to be puzzled as to how Bremer was able to raise enough money to purchase a car, follow him around the country and stay in luxurious hotels. Wallace would like to have access to the White House tapes which were recorded around the time he was shot to learn if the White House plumbers might have been involved in the assassination attempt.

The *Times* says its own investigation has been unable to uncover any hard evidence of a conspiracy. □

leads concerning Oswald's activities and connections.

At the end of the discussion, former CIA director Allen Dulles, a member of the commission, stated, "I think this record ought to be destroyed."

Weisberg has also obtained FBI chemical test results (spectrographic analysis) which compare bullets and bullet fragments which were removed from Dealey Plaza following the assassination. Neither these tests nor the Ford transcript have ever before been publicly released.

conspiracy — Castro's revenge. Activists who have waged an 11-year battle to crack the loney nut veneer now gird themselves for a fresh attempt at uncovering the coverup.

As "the company" attracts the attention it so richly deserves, the rush of events reveals a split in the American media. CBS and the *Times* show some curiosity, while *Newsweek* and the *Washington Post* cover fast for "the company."

Executive Action

The *New Times* cover story explores Lee Oswald's handling by U.S. Intelligence. Robert Sam Anson indicates that Oswald had invisible means of support behind his travels to and from the Soviet Union. The State Department's token Marxist, Oswald was open-minded enough to associate with CIA and right-wing elements in Dallas and New Orleans upon his return from Russia.

The *New York Times* learns of CIA/Mafia collaboration in murder plots seven years after D.A. Garrison — and the *Times* is shocked by its "revelation."

Harrison Salisbury, the *New York Times* editor who debated publicly on the side of the Warren Commission, now selects *Penthouse* as the forum for his article, "Gentlemen Killers of the CIA."

New York magazine contributes a fictionalized account of the power struggle within the CIA — which ends in assassination.

But the latest disclosure is an unconfirmed report on a line of inquiry being pursued by the chief counsel for Rockefeller's blue-ribbon panel:

"Belin is said to be exploring the theory that the compilation of dossiers, disruption of radical groups, wiretapping and interception of mail, and other illegal activities attributed to the CIA were all the acts of a single deranged individual acting alone... 'the lone character assassin.'"
