Dear Harold:

Because it has been obvious how busy you have been, and how overburdened with irrelevant intrusions, I've foreborne sending anything on the Hearst case, or, with a single exception, on either the Fromme and Moore ladies. However, in assembling the enclosed to send along, I decided it wouldn't take too much of your time and might even provide a little comic relief if I mentioned some of the most outstandingly phony features of all three cases.

The main thing about the Hearst capture seems to us to be the probability that the fugitives and the feds and the family had reached some sort of deal some time ago and the general impression is that Patty, the Harrises and Miss Yoshimura were just waiting to be taken in. It was all pretty casual and nobody seems to have been the least bit uptight in spite of the rumor that Patty wet her pants when the FBI told her to freeze. Only the Chronicle carried that, and it fits nothing else in the story. Persumably someone on the Chronicle is anti-Hearst. When you share publishing facilities with a Hearst outfit like the Ex, I suppose you can be excused if you make a show now and then of not liking it. The Hearst line on Patty since she turned revolutionary has been from the beginning that she was brainwashed. The Hallinans, pere et fils, are cornball enough to go along with that. Now F. Lee Bailey has appeared in the picture, but it remains/if he will pursue the same argument.

In any case, we wonder how much the FBI's trables with the Senate and House intelligence committees had to do with the decision to haul in the SLA survivors just at this particular time.

Regarding the two ladies who allegedly tried to fill Mr. Ford full of holes, this appears to us to be a case of bad going to worse. We thought the **Col**orado Congressman was right on target when he remarked after Miss Fromme's act that at long last, for the first time since William McKinley, a Republican President has been found worth shooting. (Remember Nixon's phony assassination attempt incident in New Orleans ?).

The significant thing about Miss Fromme seems to be that she made no attempt to melt into the crowd, but instead wore her Little Red Riding Hood costume and in general attmacted as much attention as possible before she pulled the gun. When she did, she didn't even pull back the cocking mechanism, and to make absolutely sure no one was hurt she saw to it that although four bullets were actually in the magazine, none was in the chamber.
