Possible Guban Associations of Jook Ruby.

## I. Associations Supported by Substantial Evidence.

Mr. Ray Robert Maksown, convicted in Mouston, Texas of colling arms to Fidel Castro, has stated that in approximately April 1959, after he had received considerable notoristy in Texas because of his arms activities and friendship with Fidel Castro, he was contacted by a man identifying Micself as Aubenstein. This individual telephoned him once and not with him personally on another occasion. In one of the conversations, Rubenstein stated that he had options on jeeps which were in Shroveport, Is. and that he desired to arrange a cale to Castro. On the other occasion, Rubenstein stated that he was representing a man in law Veges, Nevada, and that he was desirous of obtaining the release from Cube of three men who were in prison there. Rubenstein mentioned sums of between \$5,000 and \$25,000 in those conversations. Meksown how states that Rubenstein is identical to Jack Ruby.

Buby has acknowledged independently that, prior to the time that Castro fell into disfavor in the United States, he had been interested in selling Josps to Cube. Buby states that he contacted a man in becaused, Texas, whose mean he recalled was Dovis. The FBI has been unable to identify anythe engaged in the cale of arms to Cube who might be identical to the person named Davis.

Duby also admits that he visited Lewis J. Marillio in Havens, Cubs for approximately ten days sround labor Day of 1959. He states that this was his only trip to Caba and claims that the purpose of the visit with McWillie was to discuss gembling apportunities in Cubs. Marillie is a hoodles who formarly lived in Dallas, Taxas, operated in Port Worth in the 1950's, and now is an employee of the Thunderbird Hotel in Les Vegas, Nevada. McWillie first want to Havens as a manager of the Tropicsus Hotel and Casino in the fall of 1953, after Castro came to power. McWillie was apparently dispossessed by Castro and returned to the United States in January 1961. In early 1963, Buby purchased a yistel in Dallas for McWillia and had it mailed to Las Vegas. McWillia never claimed the pistol, and it was returned to Dallas.

The number and length of Ruby's stays in Cube are not entirely clear. Andy admits to having been in Cube only once: in 1999 for about ten days. However, records of the handgration and Naturalization Scrvice about that Ruby flow to Havana from Milaul on the night of September 12, 1999 and returned to How Orleans on September 13, 1999. Ruby has not explained this trip, unless it is the trip to which Ruby admits. In addition, haby is also known to have made inquiries in the fall of 1963 concerning the taking of a Cerribean Cruise; however, it is not known what offerts he made to arrange such a trip.

Buty also has evidenced some acphistisation with respect to the various political groups occounsed with Cuben affairs. For example, of the press conference which District Attorney Henry Wode held in the late avaning of Hovember 22nd, Wade stated that Canald was a number of the "Free Cube Committee." More than one newspaper reporter has recalled that Ruby interrupted Vade when he made that statement and pointed out that Commid was a needer of the Pair Play for Cube Committee and that there was a great difference between the Pres Cube Committee and the FRCG.

On November 26, 1963, agains of the United States Secret Service ware contacted by a reliable informent in Chicago who claimed that he had been contacted by certain percent interested in purchasing ours for enti-Centro Cuben groups and that the person who contacted the informent had stated "our beckers are wealthy Jess and as soon as me (they) get rid of Kennedy, so'll have plenty of money." The Informat later elected Secret Service Agents to Auribor meetings with the peruma with whom he had been in contact. One of the Cubana involved in this group is a number of the 10th of November severent and another is a manher of the Directory of Student Revolutionaries (DRE). The 10th of November was originally came to the United States on July 6, 1960 and ment impediately to Dollar, Tomas where he was employed by the C. J. Simpson Drilling Company. He has retained his contacts with Mr. C. J. Simpson. The Secret Service is endeavoring to establish an undercover relationship with this Cuban group and se have asked that the Commission be kept informed on activities in Chicago.

## II. RESOUR

Seven or eight different ruscre also link Ruby to Cube. An FBI informant in Atlanta coys Buby was a gun rusmer to Cube in the early 1950's. A woman claims that her busband, not located by the FBI, heard Ruby talk in Florida about Cuban gun running activities in 1952. Another person claims a phone call was placed in 1956 from his house to a man in Dallas maked Ruby by a man landing at the informant's Florida dock with a boat load of Cubans. A prostitute, formarly exployed by Ruby as an exotic dancer, claims that in 1961 her husband and Ruby discussed chiaining Enrield rifles in Maxico for sale to an unidentified Cuban group. Two runnes allege that Ruby visited Cube in 1963 and still has contacts in Havans. And a Permsylvania women claims she saw the names Ruby and Oswald written on a piece of paper believed to have come from the house of a neighboring Cuban refuges who formarly cased newspapers in Cuba.
